RESOLUTION NO. 2017-093

A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA), FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), WITH THE ORMOC CITY CHAMBER OF COMMERCE AND INDUSTRY (ORCHAM) TO CONDUCT JOINT EFFORT IN THE PROMOTION AND DEVELOPMENT OF BUSINESS IN ORMOC CITY BY FACILITATING COVERED PROGRAMS OF PRIVATE AND GOVERNMENT SECTOR.

WHEREAS, this august Body was in receipt of an Indorsement from the Office of the City Mayor dated April 03, 2017, requesting therein for the passage of a resolution granting the City Mayor Richard I. Gomez, authority to enter into and sign the Memorandum of Agreement (MOA) by and between the City Government of Ormoc and the Ormoc City Chamber of Commerce and Industry (ORCHAM) for the conduct of joint effort in the promotion and development of business in Ormoc City by facilitating covered programs of Private and Government sector, a photocopy of the final MOA is hereto attached and made an integral part hereof;

WHEREAS, the ORCHAM is an organization of local businessmen established to promote trade and investments in the area towards the attainment of sustainable and equitable development of the local government and private sectors wherein among its purposes is to serve as the voice of local businesses and an independent forum for the development of a consensus of the business community on matters of local or national concern as well as fostering closer relations, understanding and cooperation with the agricultural, commercial and industrial sectors of the economy in the locality;



WHEREAS, ORCHAM has been recognized by LGU Ormoc as an accredited organization and partner to implement its programs and services with the City Government of Ormoc;

WHEREAS, the City Government of Ormoc commends the Ormoc City Chamber of Commerce and Industry of its goals and actions toward the attainment of sustainable and equitable development for the City and recognizes the association as the business arm of the CITY OF ORMOC;

WHEREAS, in view of its role as the business arm of the CITY OF ORMOC, the City Government of Ormoc seeks to provide the ORCHAM with an office space for it to effectively function in the promotion of trade investments, as well as strengthening relevant concerns and issues affecting the business sector;

WHEREAS, the parties thereto are committed in collaborating to enter into this partnership with full knowledge, commitment and willingness in the fulfillment of their responsibilities contained thereon and that are directed towards the economic development of Ormoc City;

WHEREAS, upon close and thorough review, this Sanggunian, finds that the MOA is not contrary to law and existing contracts, and that its aim is extremely beneficial so as to encourage businesses to strive for excellence in delivering their products and services to the public and to provide incentives to businesses not only rendering outstanding services to the community but also to help promote the economic development of Ormoc City and provide sustainable employment to the people of Ormoc City;

WHEREFORE, on motion of SP Member Benjamin S. Pongos Jr., Chairman, Committee on Laws and Ordinances and Trade, Commerce and Industry, severally seconded by SP Members Tomas R. Serafica, Nolito M. Quilang and Mariano Y. Corro; be it
