RESOLUTION NO. 2017-098

*A RESOLUTION AUTHORIZING AND INTERPOSING NO
OBJECTION TO THE DISPOSAL OF THE BARANGAY
OUTPOST LOCATED AT BARANGAY CAGBUHANGIN, ORMOC
CITY THROUGH DEMOLITION AND THE SALE OF ITS SCRAP
STEEL BARS AND OTHER SALVAGED MATERIALS STILL OF
VALUE.*

WHEREAS, this Sanggunian received an Indorsement from the Office of the City Mayor dated May 3, 2017 endorsing the letter of Punong Barangay Eduardo G. Nazario, relative to the demolition of the existing Tanod outpost of Barangay Cagbuhangin, Ormoc City and the passage of the necessary Resolution relative thereto, including whether or not this august Body interposes no objection thereto;

WHEREAS, the Section 379, Title VI, Book II of Republic Act No. 7160, otherwise known as the Local Government Code of 1991 states that when property of any local government unit has become unserviceable for any cause or is no longer needed, it shall, upon application of the officer accountable therefor, be inspected and appraised by the provincial, city or municipal auditor, as the case may be, or his duly authorized representative or that of the Commission on Audit and, if found valueless or unusable, shall be destroyed in the presence of the inspecting officer;

WHEREAS, through a letter addressed to the City Mayor, Barangay Cagbuhangin Punong Barangay Eduardo G. Nazario had informed the former that said Tanod Outpost which was damaged by Typhoon Yolanda is no longer usable and further requested for the demolition of the structure so that a proposed Child Friendly Learning Center for the Barangay shall be constructed on the same site;

WHEREAS, in relation thereto this Sanggunian was also in receipt of a letter dated April 25, 2017 from the Supervising State Auditor of the Commission on Audit (COA) interposing no objection to the said building demolition subject to the passage of a resolution from this Sanggunian authorizing the same;

WHEREAS, in an Inspection and Appraisal Report issued by the Disposal Committee of the City dated April 20, 2017, a finding therein stated that the subject Barangay structure is indeed considerably damaged and beyond economic repair, making the same unsafe for future use;

WHEREAS, after careful and thorough review of the documents submitted, foregoing premises considered, this Sanggunian finds and recognizes the need to authorize the disposal of the said structure and the sale of all remaining salvaged materials that are still of value in order to pave the way for the construction of the proposed Barangay Child Friendly Learning Center, a noble project for the Barangay, and that the aims of the requested resolution are favorable and advantageous to all parties concerned, and therefore, most deserving of this august Body's prompt and favorable consideration;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of SP Member Benjamin S. Pongos, Jr., Chairman, Committee on Public Properties, severally seconded by SP Members Vincent L. Rama, Tomas R. Serafica, Eusebio Gerardo S. Penserga, Mario M. Rodriguez, Nolito M. Quilang, John Eulalio Nepomoceno O. Aparis II, Lea Doris C. Villar and Mariano Y. Corro; be it


