RESOLUTION APPROVING THE FIVE (5) AN CMNIBUS APPLICATIONS FOR ACCREDITATION WITH GOVERNMENT UNIT OF ORMOC, ACCORDANCE WITH THE PROVISIONS OF ORDINANCE VO.009 DATED OCTOBER 16, 2014 OF THE FOLLOWING CIVIL SOCIETY ORGANIZATIONS, TO WIT:

- ORMOC CITY FISHPOND OPERATORS ASSOCIATION (OCFOA)
- 2. SUMANGGA FARMERS ASSOCIATION (SUFA)
- 3. ORMOC RICE HYBRID SEED PRODUCERS MULTI-PURPOSE COOPERATIVE (ORHSEPRO-MPC)
- 4. JUATON WOMEN'S LIVELIHOOD ASSOCIATION (JWLA)
- 5. ORMOC LOCAL PRODUCERS ASSOCIATION INC. (OLPA)

WHEREAS, five (5) separate applications for accreditation with the Local Government Unit of Ormoc were received by this august Body from the following Civil Society Organizations (CSOs), to wit;

- 1. Ormoc City Fishpond Operators Association (OCFOA)
- 2. Sumangga Farmers Association (SUFA)
- 3. Ormoc Rice Hybrid Seed Producers Multi-Purpose Cooperative (ORHSEPRO-MPC)
- 4. Juaton Women's Livelihood Association (JWLA)
- 5. Ormoc Local Producers Association Inc. (OLPA)

WHEREAS, Ormoc City Fishpond Operators Association (OCFOA), signified its intention to obtain a CSO accreditation with LGU-Ormoc in compliance with the DILG Memorandum Circular No. 2013-70. OCFOA members organized themselves into an association and registered with the Department of Labor and Employment (DOLE) to improve their standard of living and enhance the general welfare of its members. Among its purposes is to promote mutual aid and protection as well as to provide knowledge and skills and equip its members with effective and innovative way to fishpond management;

WHEREAS, Sumangga Farmers Association (SUFA), is a legitimate workers' association duly registered under Department of Labor and Employment and currently seeking for an accreditation with LGU-Ormoc. To develop a sustainable livelihood thru the conduct of activities with the aim of uplifting the economic condition of the members is among the association's objectives;

WHEREAS, Ormoc Rice Hybrid Seed Producers Multi-Purpose Cooperative (ORHSEPRO-MPC), is an organization registered with Cooperative Development Authority (CDA). Among its services offered are the Palay Production Loans, Palay Buying and Organic Fertilizer Loans. The organization members and officers undergone trainings and seminars facilitated by CDA. Its primary purpose is to produce and market hybrid seeds and help its farmer-members access to different farm inputs at fair and reasonable cost;

WHEREAS, Juaton Women's Livelihood Association (JWLA), is a group of women formed into an association who are willing to undergo seminars/trainings and participate in all government activities to improve and enhance their standard of living. Among the association's objective is to be able to serve the needs of women as its direct beneficiaries. JWLA is an association registered under the Department of Labor and employment;

WHEREAS, Ormoc Local Producers Association Inc. (OLPA), is a non-stock corporation registered under the Securities and Exchange Commission. Its primary purpose is to represent, promote and lobby the interest of micro, small and medium scale producers in Ormoc City as well as to help promote the city's tourism programs by offering the best of our locally made and homegrown products to raise the quality image of Ta'ak Ormoc products and goods;

WHEREAS the call for accreditation of CSOs was pushed by this Sanggunian in accordance with the provisions of Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, Section 2.1 of Ordinance No.009 provides among others that an organization may still be accredited after the prescribed sixty (60) – day period within which application for accreditation shall be accepted, for purposes other than representation to local special bodies;

WHEREAS, this Sanggunian, after thorough review of the aforementioned applications finds that the same are in order, and the purposes of the sought accreditation are all directed to promote mutual aid, protection, and socio-economic development among its members as well as to establish a strong linkage with the LGU and actively participate in the implementation of the diverse programs and projects of the government to promote inclusive growth;
