## RESOLUTION NO. 2017-100

A RESOLUTION GRANTING AUTHORITY TO THE CITY ACCOUNTANT TO CHARGE AGAINST THE CURRENT YEAR APPROPRIATION THE TOTAL AMOUNT OF ONE MILLION THREE MUNDRED SIXTY-EIGHT THOUSAND EIGHT HUNDRED FORTY-FIVE PESOS & 30/100 (P1,368,845.30) RERESENTING PAYMENT OF PRIOR YEAR OBLIGATIONS OF VARIOUS LGU-ORMOC OFFICES WITH THE CONCERNED SUPPLIERS IN CY 2016.

WHEREAS, an indorsement dated April 26, 2017 from the Office of the City Mayor Richard I. Gomez was received by this august Body requesting for the passage of a resolution allowing the 2016 unpaid purchases of various LGU-Ormoc offices to be charged to current year appropriation in the total amount of ONE MILLION THREE HUNDRED SIXTY-EIGHT THOUSAND EIGHT HUNDRED FORTY FIVE PESOS & 30/100 (P1,368,845.30) broken down as follows:

WHEREAS, the subject obligations are deemed legitimate as all transactions were covered with appropriate Purchase Orders (POs) duly approved in CY 2016 and the goods/items were received in good state by the concerned offices hence, the need to be settled for the mutual good and interest of both the LGU and the suppliers involved;

WHEREAS, in order to effect the necessary payments of the aforementioned obligations, a resolution from the Sangguniang Panlungsod allowing that the same be charged to the Current Year Appropriation of each concerned office is required in as much as the expenditures are still part of the Year 2016;
