RESOLUTION NO. 2017-110

A RESOLUTION AUTHORIZING THE CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT FOR AND IN BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) WITH THE DEPARTMENT OF AGRICULTURE - NATIONAL MEAT INSPECTION SERVICE (DA-NMIS), FOR THE IMPLEMENTATION AND RELEASE OF THE FINANCIAL ASSISTANCE FOR THE RECONSTRUCTION OF THE SLAUGHTERHOUSE OF ORMOC CITY.

WHEREAS, the 14TH Sangguniang Panlungsod ng Ormoc received an endorsement letter from the Office of the City Mayor on May 3, 2017 for consideration of the Memorandum of Agreement (MOA) to be entered into by the Local Government Unit of Ormoc (LGU-ORMOC) and the Department of Agriculture - National Meat Inspection Service, referred to as DA-NMIS, represented by its Executive Director, DR. ERNESTO S. GONZALES;

WHEREAS, the MOA is for the implementation and release of the financial assistance or fund for the reconstruction of the slaughterhouse under the Yolanda Rehabilitation and Reconstruction Program (YRRP);

WHEREAS, in support for the YRRP, the Department of Agriculture (DA), as primarily tasked with food production to ensure food security and food staples sufficiency, provided funds which shall be handled and managed by the NMIS, as trustee, for the implementation of the repair/reconstruction of the slaughterhouse of its recipient LGU that was devastated by the super typhoon Yolanda;

WHEREAS, the City of Ormoc was one of the localities that was devastated by the super typhoon where its government buildings and facilities were damaged, and any agencies providing assistance would greatly help to its recovery, reconstruction and rehabilitation;

WHEREAS, under the MOA, the DA-NMIS shall allocate and transfer the amount of Ten Million Pesos (PHP 10,000,000.00) to the City of Ormoc as a recipient LGU under the YRRP reconstruction and/or rehabilitation of the City's slaughterhouse;

WHEREAS, upon close and thorough review, this Sanggunian finds that the MOA is truly beneficial as it aims to provide financial support for the reconstruction and rehabilitation of the Ormoc City Slaughterhouse and further, is not contrary to law, public policy, public morals and existing contracts, therefore deserves an affirmative action and support;

NOW THEREFORE, on joint motion of SP Member Tomas R. Serafica, Chairman of the Committee on Agriculture and SP Member Benjamin S. Pongos, Jr. Chairman, Committee on Laws & Ordinances, severally seconded by SP Members Mario M. Rodriguez, Eusebio Gerardo S. Penserga, Benjamin S. Pongos, Jr., Lea Doris C. Villar, Nolito M. Quilang, John Eulalio Nepomuceno O. Aparis II and Mariano Y. Corro; be it


