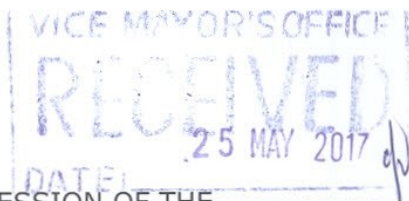

RESOLUTION NO. 2017-113

A RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE AGAINST THE CURRENT YEAR APPROPRIATION OF THE CITY MAYOR'S OFFICE UNDER THE ACCOUNT- PUBLIC EMPLOYMENT SERVICES PROGRAM (PESP) - OTHER GENERAL SERVICES, THE AMOUNT OF THIRTY ONE THOUSAND TWO HUNDRED PESOS (P31,200.00), AS PAYMENT OF PRIOR YEAR OBLIGATION ON SALARIES OF SIX (6) JOB ORDER EMPLOYEES ASSIGNED AT CITY TOURISM OFFICE FOR THE MONTH OF DECEMBER, 2016.

WHEREAS, the Office of the City Mayor forwarded an urgent Indorsement dated May 9, 2017 to this Sanggunian for consideration, relative to the request of Mr. Vincent L. Emnas, City Administrator, for the payment of prior year obligation of the City Mayor's Office (CMO) in the total amount of THIRTY ONE THOUSAND TWO HUNDRED PESOS (P31,200.00) to be charged to Current Year Appropriation under the account CMO- Public employment Services Program - Other General Services;

WHEREAS, the aforesaid obligation covers the services of Six (6) Job Order employees assigned at City Tourism Office for the period December 1-31, 2016 but was left unpaid due to the closing of the books of accounts at the end of year 2016, hence, a Sangguniang Panlungsod resolution is necessary to appropriately charge its payment against the Current Year Appropriation;

WHEREAS, the City Budget Officer, the City Treasurer, and the OIC-City Accountant, through a certification dated May 8, 2017, certified that the amount of THIRTY ONE THOUSAND TWO HUNDRED PESOS (P31,200.00), for the payment of actual services rendered by the Six (6) Job Order employees for the month of December 2016, is deemed available chargeable against current year appropriation under MOOE account of PESP - Other General Services - of the Office of the City Mayor;


