RESOLUTION NO. 2017-122

A RESOLUTION RATIFYING AND CONFIRMING THE  
AUTHORITY OF ORMOC CITY MAYOR RICHARD I. GOMEZ  
TO ENTER INTO AND SIGN THE REVISED MEMORANDUM  
OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL  
GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) WITH THE  
ORMOC FESTIVAL AND CULTURAL FOUNDATION (OFCF),  
REPRESENTED BY ESTRELLA MARIA S. PANGILINAN FOR  
THE IMPLEMENTATION OF THE CULTURAL MAPPING  
PROJECT IN ORMOC CITY.

WHEREAS, this Sanggunian passed SP Resolution No. 2017-111 which granted authority to Ormoc City Mayor Richard I. Gomez to enter into and sign the Memorandum of Agreement (MOA) with Ormoc Festival and Cultural Foundation, Inc., for the implementation of the Cultural Heritage Mapping Project in Ormoc City;

WHEREAS, a revision of the above-cited MOA is necessary because of the change of funding source from the Special Education Fund (SEF) to the LGU Ormoc General Fund;

WHEREAS, the parties already signed the revised MOA because of the urgency to conduct the seminars and other activities of the project and the need to process the release of funds needed by OFCF in implementing the Cultural Mapping Project;

WHEREAS, this Sanggunian was in receipt of the signed Revised MOA with a request from the Office of the City Mayor to ratify the said revised MOA;

WHEREAS, the positive act of the Sangguniang Panlungsod to ratify the revised MOA is indispensable to make the act of the City Mayor valid and also to nullify SP Resolution No. 2017-111 and the original MOA;

WHEREAS, upon close and thorough review, this Sanggunian, finds that the Revised MOA is not contrary to laws, and existing contracts, and that it is in the best interest of the City to pursue the success of the Cultural Mapping Project in order to provide impetus for the promotion of cultural industries and develop a tourism campaign based on the outputs of the project;

WHEREFORE, on joint motion of SP Member Nolito M. Quilang, Chairman, Committee on Education, Culture, and Arts and SP Member Benjamin S. Pongos, Jr., Chairman, Committee on Laws and Ordinances, severally seconded by SP Members Tomas R. Serafica, Gregorio G. Yrastorza III, John Eulalio Nepomuceno O. Aparis II, Lea Doris C. Villar and Mariano Y. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION RATIFYING AND CONFIRMING THE AUTHORITY OF ORMOC CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN THE REVISED MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU ORMOC) WITH THE ORMOC FESTIVAL AND CULTURAL FOUNDATION (OFCF), REPRESENTED BY ESTRELLA MARIA S. PANGILINAN FOR THE IMPLEMENTATION OF THE CULTURAL MAPPING PROJECT IN ORMOC CITY;
