RESOLUTION NO. 2017-124

A RESOLUTION GRANTING AUTHORITY TO THE OIC-CSWDO, MS. DELIA D. CORBO, TO UTILIZE THE CYs 2015 AND 2016 CONTINUING APPROPRIATION FOR CAPITAL OUTLAY- MOTOR VEHICLES UNDER THE CITY SOCIAL WELFARE AND DEVELOPMENT OFFICE IN THE TOTAL AMOUNT OF FOUR MILLION PESOS (P4,000,000.00) FOR THE PURCHASE OF THREE (3) UNITS BRAND NEW MOTOR VEHICLES.

WHEREAS, the City Mayor Richard I. Gomez through an Endorsement dated April 26, 2017 had forwarded to this Sanggunian for consideration the request of Ms. Delia D. Corbo, OIC-CSWDO, for the utilization of their office appropriation for Capital Outlay-Motor Vehicles in the total amount of Four Million Pesos (P4,000,000.00) for the purchase of Three (3) units service vehicles;

WHEREAS, as conveyed by Ms. Corbo in her letter request dated April 19, 2017, the current service vehicles of the CSWD Office are in deteriorating state and some are no longer serviceable which situation seriously affects the day to day operations of their office especially in the mobilization of CSWD personnel stationed at the Six (6) District Centers of the city;

WHEREAS, the CSWD Office is one of the key offices in the forefront of providing social services to the Ormoc City constituents hence, it is imperative that the problem on the availability of service vehicles in same office be promptly addressed in order not to hamper the continuous implementation of its different programs and services;

WHEREAS, the procurement of new service vehicles for CSWDO use is deemed vital to public service as it will aid the department in its drive to effectively and efficiently perform its thrusts and further strengthen the delivery of social services for the benefit of the people;

WHEREAS, the necessary funds to cover the proposed purchase of Three (3) units Motor Vehicles are available as certified by the City Budget Officer, OIC- City Accountant and City Treasurer through a Certificate of Availability of Funds dated February 21, 2017, to be taken from the account- Capital outlay for Motor Vehicles Unexpended Continuing Appropriation for CY 2015 in the amount of Three Million Pesos (P3,000,000.00) as authorized by the Sangguniang Panlungsod through Appropriation Ordinance No. 2015-001, and from CY 2016 appropriation in the amount of One Million Pesos (P1,000,000.00) as authorized by the Sangguniang Panlungsod through Appropriation Ordinance No. 2016-001;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion presented by SP Member Mario M. Rodriguez, Chairman, Committee on Finance and Appropriation, severally seconded by SP Members Nolito M. Quilang, Gregorio G. Yrastorza III, John Eulalio Nepomuceno O. Aparis II, Mariano Y. Corro, Tomas R. Serafica and Benjamin S. Pongos, Jr.; be it


