RESOLUTION NO. 2017-129

A RESOLUTION AUTHORIZING THE CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), WITH THE LOCAL GOVERNMENT AGENCY (LGA) OF THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT (DILG), AND THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT REGIONAL OFFICE VIII RELATIVE TO THE RENEWAL OF PARTNERSHIP FOR THE IMPLEMENTATION OF THE PROJECT ENTITLED "SUSTAINABLE DEVELOPMENT GOALS FAMILY-BASED ACTIONS FOR CHILDREN AND THEIR ENVIRONS IN THE SLUMS (SDG-FACES) PROJECT."

WHEREAS, the City Mayor Richard I. Gomez through an Indorsement dated May 19, 2017 forwarded to this august Body for consideration the Memorandum of Agreement (MOA) to be entered into by LGU-Ormoc with the Local Government Agency of the Department of Interior and Local Government (LGA-DILG) and the Department of Interior and Local Government Regional Office VIII, relative to the renewal of partnership for the implementation of the project entitled "Sustainable Development Goals Family-Based Actions for Children and their Environs in the Slums (SDG-FACES) Project," a copy of the final MOA is hereto attached and made an integral part hereof;

WHEREAS, this project is in line with the United National Sustainable Goals of 2030 in which the Philippine Government is a signatory;

WHEREAS, The Local Government Academy (LGA), the training arm of the Department of the Interior and Local Government (DILG), is bringing poverty eradication to the grassroots by continuing the Millennium Development Goals – Family-based Actions for Children and Their Environs in the Slums (MDG-FACES) in the SDG era;

WHEREAS, this program, renamed as the SDG-FACES project, focuses on empowering mothers and women-headed households living in slums to take the lead in managing the Family SDG Covenant;

WHEREAS, the subject MOA clearly and plainly encapsulates the terms and conditions of the agreement of the parties thereto, including their specific roles and obligations towards the attainment of the lofty ends of the same, and this Sanggunian, upon thorough review, finds that overall it is favorable as it equips LGUs with the resources, skills, and knowledge to uplift their communities, therefore, is most deserving of this august Body's prompt and favorable consideration;

WHEREFORE, on motion of SP Member Benjamin S. Pongos, Jr. Chairman, Committee Laws and Ordinances, severally seconded by SP Members Mariano Y. Corro, Lea Doris C. Villar, John Eulalio Nepomuceno O. 
