RESOLUTION NO. 2017-130

*A RESOLUTION ADOPTING THE ORMOC CITY CONTINGENCY
PLAN FOR ORMOC FLOOD-AFFECTED BARANGAYS OR
"OPLAN LUNOP".*

WHEREAS, Section 16 of the Local Government Code of 1991 states in part that, "Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, promote health and safety, enhance the right of the people to a balanced ecology, enhance economic prosperity and social justice, and preserve the comfort and convenience of their inhabitants";

WHEREAS, Republic Act 10121, otherwise known as the "Philippine Disaster Risk Reduction and Management Act of 2010" empowers Local Government Units to provide mitigating and preventive programs, prepare for and earnestly respond to disaster/calamities/crisis/complex emergencies;

WHEREAS, local recorded history tells us that the City of Ormoc has borne the loss of life and property, and suffered adverse health impact, social and economic disruption and environmental damage, specifically from typhoon and flooding caused by such calamity;

WHEREAS, the City Disaster Risk Reduction and Management Council (CDRRMC) has formulated a Contingency Plan for Ormoc Flood- Affected Barangays consistent with the mandate to provide for a mechanism that may be activated in specific areas under certain conditions;

WHEREAS, the Contingency Plan for Ormoc Flood- Affected Barangays formulated by the CDRPMC provides for standard operating for every scenario;

WHEREAS, the Contingency Plan for Ormoc Flood- Affected Barangays formulated by the CDRPMC is a measure that will enable the City to protect human lives and property during these unforeseen events, ensure coordination between and among offices and immediately attend to the needs during certain emergencies, including but not limited to public assistance, proper utilization of funds and information dissemination;

WHEREFORE, on motion made by SP Member Gregorio G. Yrastorza III, Vice-Chairman, Committee on Public Safety, severally seconded by SP Members Mario M. Rodriguez, Nolito M. Quilang, John Eulalio Nepomuceno O. Aparis II, Lea Doris C. Villar, Mariano Y. Corro, Tomas R. Serafica and Benjamin S. Pongos, Jr.; be it

RESOLVED, AS IS IT HEREBY RESOLVED, to pass a *RESOLUTION ADOPTING THE ORMOC CITY CONTINGENCY PLAN FOR ORMOC FLOOD-AFFECTED BARANGAYS OR "OPLAN LUNOP"*;

ADOPTED, June 08, 2017.
