RESOLUTION NO. 2017-132

A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ, FOR AND ON BEHALF OF LOCAL GOVERNMENT UNIT OF ORMOC CITY (LGU-ORMOC), TO ACCEPT AND SIGN THE DEED OF DONATION IN THE AMOUNT OF TWO HUNDRED THOUSAND PESOS (PHP200,000.00) FROM MS. CHARIE SICSIC AND MR. JIM REINDLE FOR THE CONVERSION PROJECT OF THE OLD CITY HALL TO ORMOC CITY MUSEUM CENTER.

WHEREAS, this august Body was in receipt of an Indorsement from the Office of the City Mayor dated May 11, 2017, requesting therein for the passage of a resolution granting authority to Ormoc City Mayor Richard I. Gomez to accept and sign the Deed of Donation from Ms. Charie Sicsic and Mr. Jim Reindle as Donors of financial assistance amounting to Php200,000.00 in favor of the LGU-Ormoc as Donee for the conversion project of the old City Hall to Ormoc City Museum Center, a copy of said Deed of Donation is hereto attached and made an integral part thereof;

WHEREAS, the City of Ormoc has cultural properties of both local and national significance that embody and exemplify the richness and abundance of its culture and history requiring its conservation and protection for the people of Ormoc and Leyte;

WHEREAS, with Ormoc City as a vital and growing community, it aims to assess its cultural offering with institutions to offer its youth, adults, families and visitors to provide a better understanding of its history and culture and creative expression;

WHEREAS, having a museum in the former City Hall will give the City a suitable adaptive re-use of an important landmark which will add a new attraction and a cultural and educational institution to the City;

WHEREAS, through City Ordinance No. 006 Series of 2016, the old Ormoc City Hall was declared as a City Cultural Property;

WHEREAS, one of the Donors is an Ormocanon who is currently residing in the United States of America and will be coming home to turn-over some donations including the financial donation worth Php200,000.00 to support the cultural development initiatives of the City;

WHEREAS, said Deed of Donation mentions that in consideration of an act of cooperation, liberality and generosity, the Donors, Ms. Charie Sicsic and Mr. Jim Reindle, voluntarily give, transfer and convey unto the Donee, LGU-Ormoc, Php200,000.00 which will be turned over on June 30, 2017 during the Balikbayan Night at the Ormoc City Superdome;

WHEREAS, this august Body believes that said donation is done in good faith and is of great help to the City of Ormoc;

WHEREAS, this Sanggunian, after thorough examination of the aforementioned request by the City Mayor finds that it is to the best interest of the City and advantageous to the same to authorize the City Mayor to sign the Deed of Donation and accept the financial donation in order to support the conversion project of the old Ormoc City Hall, a City cultural property, against exportation, modification or demolition while preserving the same;

WHEREFORE, on motion of SP Member Benjamin S. Pongos, Jr. Chairman, Committee Laws and Ordinances, severally seconded by SP Members Vincent L. Rama, Eusebio Gerardo S. Penserga, Gregorio G. Yrastorza III, Nolito M. Quilang, John Eulalio Nepomuceno O. Aparis II, Lea Doris C. Villar and Mariano Y. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ, FOR AND ON BEHALF OF LOCAL GOVERNMENT UNIT OF ORMOC CITY (LGU-ORMOC), TO ACCEPT AND SIGN THE DEED OF DONATION IN THE AMOUNT OF TWO HUNDRED THOUSAND PESOS (PHP200,000.00) FROM MS. CHARIE SICSIC AND MR. JIM REINDLE FOR THE CONVERSION PROJECT OF THE OLD CITY HALL TO ORMOC CITY MUSEUM CENTER;
