RESOLUTION NO. 2017-134

A RESOLUTION APPROVING THE APPLICATIONS FOR ACCREDITATION WITH THE LOCAL GOVERNMENT UNIT OF ORMOC, IN ACCORDANCE WITH THE PROVISIONS OF ORDINANCE NO. 009 DATED OCTOBER 16, 2014 OF THE FOLLOWING CIVIL SOCIETY ORGANIZATIONS, TO WIT:

1. GAGMAY'NG MAG-UUMA SA CATMON ASSOCIATION (GAMACA)
2. HOPE WORLDWIDE PHILIPPINES, INC.

WHEREAS, the applications of GAGMAY'NG MAG-UUMA SA CATMON ASSOCIATION (GAMACA) and HOPE WORLDWIDE PHILIPPINES, INC., both Civil Society Organizations (CSOs), were received by this august Body requesting for accreditation with the Local Government Unit of Ormoc;

WHEREAS, GAMACA is composed of farmers residing in Barangay Catmon, Ormoc City, duly registered under Department of Labor and Employment and currently seeking for an accreditation with LGU-Ormoc. Among its primary objectives is to promote the mutual aid and protection of its members as well as to improve and enhance their standard of living;

WHEREAS, HOPE WORLDWIDE PHILIPPINES, INC., is a non-profit, non-government, faith-based charity that has been caring for needy children and youth. The organization is licensed and registered by the City Social Welfare and Development Office (CSWDO) and the Securities and Exchange Commission (SEC). HOPE, in partnership with many government and non-government organizations, currently implements a system of child welfare and protection system through its community and center-based programs in the largest urban poor communities in the Philippines;

WHEREAS, it can be recalled that this Sanggunian has enacted Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which sets the procedures for accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, Section 2.1 of Ordinance No.009 provides among others that an organization may still be accredited after the prescribed sixty (60) – day period within which application for accreditation shall be accepted, for purposes other than representation to local special bodies;

WHEREAS, this Sanggunian, after thorough review of the aforesaid applications, finds that the same are in order, and the purposes of the sought accreditation are all directed to promote mutual aid, protection, and socio-economic development among its members as well as to establish a strong linkage with the LGU and actively participate in the implementation of the diverse programs and projects of the government to promote inclusive growth;

WHEREAS, further, this august Body deems the applications to be lawful being in accordance with the provisions of the Ordinance No. 009 hence, most deserving of favorable action by this Sanggunian;

WHEREFORE, on motion of the SP Member Eusebio Gerardo S. Penserga, Chairman, Committee on Accreditation, severally seconded by the SP Members Vincent L. Rama, John Eulalio Nepomuceno O. Aparis II, Lea Doris C. Villar, Gregorio G. Yrastorza III and Mariano Y. Corro; be it
