RESOLUTION NO. 2017-135

A RESOLUTION GRANTING AUTHORITY TO THE OIC-CITY ACCOUNTANT, MRS. ROSARIO G. SERAFICA, TO CHARGE AGAINST THE CURRENT APPROPRIATION ON PUBLIC EMPLOYMENT SERVICES PROGRAM (PESP) ACCOUNT OF THE OFFICE OF THE CITY MAYOR THE AMOUNT OF THREE MILLION SEVEN HUNDRED FIFTY- FIVE THOUSAND PESOS (P3,755,000.00) FOR THE GRATUITY PAY TO JOB ORDERS (JOs) OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) AS OF DECEMBER 15, 2016.

WHEREAS, an Endorsement dated June 8, 2017 from the Office of the City Mayor was received by this august Body requesting urgent action on the request of the City Administrator, Mr. Vincent L. Emnas, for an Appropriation Ordinance to cover the payment of Gratuity Pay to Job Orders of LGU-Ormoc as of December 15, 2016 pursuant to Administrative Order (A.O.) No. 02 from the Office of the President of the Philippines dated January 31, 2017 ;

WHEREAS, A.O. No. 02 authorizes the grant of One(1) time Gratuity Pay to Job Orders and Contract of Service Workers in Government who have rendered a total or an aggregate of at least Four (4) months of satisfactory service as of December 15, 2016 and whose contracts were still effective as of same date at TWO THOUSAND PESOS (P2,000.00) each, while those with services less than Four(4) Months and also having effective contracts as of same period at ONE THOUSAND PESOS (P1,000.00) each;

WHEREAS, for purposes of determining the actual funds needed for the grant of the Gratuity Pay, the Human Resource Management Officer submitted a list of the total number of JOs assigned in various LGU Offices who were qualified to receive the benefit classified as follows:

No. of JOs w/ at least 4 mos. services & above	- 1,570 @ P2,000.00 = P3,140,000.00
No. of JOs w/ less than 4 mos. Services	- 615 @ P1,000.00 = 615,000.00

WHEREAS, the matter was forwarded to the City Budget Officer for comments and identification of possible source of funds for the benefit. Relative to this, the City Budget Officer manifested that there is no longer a need for a supplemental appropriation for the purpose considering that the amount required for the payment of Gratuity Pay totaling to THREE MILLION SEVEN HUNDRED FIFTY- FIVE THOUSAND PESOS (P3,755,000.00) is deemed available chargeable against the Public Employment Services Program (PESP) account of the Office of the City Mayor as per Certificate of Availability of Funds dated 6 June 2017 which was issued in support hereto;

WHEREAS, this august Body, upon thorough evaluation on the propriety of granting the subject Gratuity Pay, finds that it is lawful being in accordance with the provisions of A.O. No. 02, hence, most deserving of prompt favorable action;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion presented by SP Member Mario M. Rodriquez, Chairman, Committee on Finance and Appropriation, severally seconded by SP Members Vincent L. Rama, Benjamin S. Pongos, Jr., Gregorio G. Yrastorza III, John Eulalio Nepomuceno O. Aparis II, Lea Doris C. Villar and Mariano Y. Corro; be it


