

RESOLUTION NO. 2017-138

*A RESOLUTION CONFIRMING THE APPOINTMENT OF ATTY.  
JASPER M. LUCERO AS CITY GOVERNMENT DEPARTMENT  
HEAD I (CITY LEGAL OFFICER).*

WHEREAS, Section 463, par (d) of RA 7160, otherwise known as the Local Government Code of 1991, provides that heads of departments and offices shall be appointed by the Local Chief Executive with the concurrence of the majority of all the members of the Sangguniang Panlungsod and that the Sanggunian shall act on the appointment within fifteen (15) days from the date of its submission;

WHEREAS, the appointment of Atty. Jasper M. Lucero as City Department Head I (City Legal Officer) has been submitted to the Sangguniang Panlungsod for confirmation on June 7, 2017 and was referred to the Committee on Good Government on June 8, 2017;

WHEREAS, after careful examination, scrutiny and review of the qualifications, records and experiences of the appointee, the Committee on Good Government finds the appointment meritorious and therefore interposes no objection to said appointment;

WHEREAS, upon motion of SP Member Mario M. Rodriguez, duly seconded by SP Members Pongos, Yrastorza, and Aparis, the Committee on Good Government concurs with the appointment of Atty. Jasper M. Lucero as City Government Department Head I (City Legal Officer) at the committee level and endorses the matter to the plenary;

WHEREAS, the Sanggunian finding the recommendation of the Committee meritorious rules that the appointee possesses all the minimum qualifications set by law for the position and that he has none of the disqualifications under the Local Government Code or other existing law;


ADOPTED, June 22, 2017.
