A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GONEZ, FOR AND ON BEHALF OF LOCAL GOVERNMENT UNIT OF CRMOC CITY (LGU-ORMOC), TO ACCEPT AND SIGN THE DEED OF DONATION IN THE AMOUNT OF TWO THOUSAND US DOLLARS (US\$2,000.00) FROM MS. CHARIE SICSIC AND MR. JIM REINDLE AS SUPPORT TO CULTURAL DEVELOPMENT INITIATIVES OF THE CITY, THEREBY AMENDING SP RESOLUTION NO. 2017-132 DATED JUNE 15, 2017.

WHEREAS the City Mayor Richard I. Gomez through an Indorsement dated June 23, 2017 forwarded to this august Body for consideration the Deed of Donation (DOD) which reduced the amount to be donated from Two Hundred Thousand Pesos (Php 200,000.00) to the amount of Two Thousand US Dollars (US\$2,000.00) and further requesting for authority to sign and accept the same, a copy of the DOD is hereto attached and made an integral part hereof;

WHEREAS, to recall, the City Mayor had been earlier granted authority to accept a DOD by this Sanggunian thru SP Resolution No. 2017-132 dated June 15, 2017, entitled: "A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ, FOR AND ON BEHALF OF LOCAL GOVERNMENT UNIT OF ORMOC CITY (LGU-ORMOC), TO ACCEPT AND SIGN THE DEED OF DONATION IN THE AMOUNT OF TWO HUNDRED THOUSAND PESOS (PHP200,000.00) FROM MS. WHEREAS, the said Donors of said DOD had forwarded to the City Mayor's Office a request that the original amount thereon be changed to an amount equivalent to Two Thousand US Dollars (US\$2,000.00) for the same object and purpose;

WHEREAS, this Sanggunian, after thorough examination of the aforementioned request by the City Mayor, deems that it indeed is the rightful prerogative of the Donors to ultimately determine the amount of the donation that they deem appropriate for the subject donation, along with the acknowledgement and conveyance of extreme gratitude by this Sanggunian to the Donors for their magnanimity and generosity in supporting the cultural development initiatives of the City including the conversion project of the old Ormoc City Hall, a City cultural property, against exportation, modification or demolition while preserving the same, and therefore, finds the subject request to be meritorious and deserving of full support;
