RESOLUTION NO. 2017-150

A RESOLUTION GRANTING AUTHORITY TO CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN THE SCHOLARSHIP CONTRACT FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), WITH THE ORMOC CITY SCHOLARSHIP PROGRAM GRANTEES IN CONFORMITY WITH 14TH SANGGUNIANG PANLUNGSOD ORDINANCE NO. 028, SERIES OF 2017.

WHEREAS, an Indorsement dated June 22, 2017 from the Office of the City Mayor was received by this august Body urgently requesting for the passage of a resolution granting authority to the City Mayor Richard I. Gomez to enter into and sign for and on behalf of LGU-Ormoc, the Scholarship Contract with the City Scholarship Program grantees, a copy of the Contract is hereto attached and made an integral part hereof;

WHEREAS, the execution of the Contract by the concerned parties is a precondition of the recently enacted "Ormoc City Scholarship Program Ordinance" denominated as Ordinance No. 028, Series of 2017 of this Sanggunian;

WHEREAS, Section 10 of Ordinance No. 028 provides that a contract shall be entered into by the scholars or herein referred to as the "grantees" to clearly specify the terms and conditions and set the guidelines that the grantees need to comply with to ensure and maintain their entitlement to the scholarship program;

WHEREAS, at present, there are 124 grantees of the City Scholarship Program, consisting of 34 continuing grantees and 90 new grantees who were selected based on the approved procedures and parameters set under Ordinance No. 028 and it follows that all scholarship grantees are covered and bound to this Scholarship Contract object of the requested authority of the City Mayor to enter into and sign with;

WHEREAS, it is the declared policy of LGU-Ormoc to protect and promote the right of its constituents to quality education and provide access mechanism to the underprivileged but deserving students in the completion of a college degree or technical or vocational education and provide them with opportunities to harness their potentials that will translate not only to their personal advancement but as well as to local and national economic development;

WHEREAS, the contract encapsulates the terms and conditions that shall be adhered to by both parties in the entire scholarship grant, and this Sanggunian upon close and thorough review of the same, finds the stipulations thereon to be in conformity with the existing City Scholarship Ordinance and that it is most deserving of prompt favorable action to realize its noble and lofty goals of making education accessible to the underprivileged but deserving Ormocanon youths;

WHEREFORE, on motion of SP Member Benjamin S. Pongos, Jr., Chairman, Committee on Laws and Ordinances, severally seconded by SP Members Vincent L. Rama, Nolito M. Quilang, John Eulalio Nepomuceno O. Aparis II, Tomas R. Serafica and Mariano Y. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION GRANTING AUTHORITY TO CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN THE SCHOLARSHIP CONTRACT FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), WITH THE ORMOC CITY SCHOLARSHIP PROGRAM GRANTEES IN CONFORMITY WITH 14TH SANGGUNIANG PANLUNGSOD ORDINANCE NO. 028, SERIES OF 2017;
