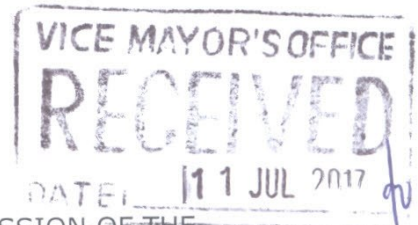

RESOLUTION NO. 2017-154

*A RESOLUTION AUTHORIZING THE ORMOC CITY MAYOR
RICHARD I. GOMEZ TO ACCESS AND UTILIZE THE CITY'S
UNEXPENDED BALANCES OF THE LOCAL DISASTER RISK
REDUCTION AND MANAGEMENT FUND (LDRRMF).*

WHEREAS, on July 6, 2017, an earthquake with 6.5 magnitude struck the City of Ormoc;

WHEREAS, considering the damage brought about by the earthquake, the Ormoc City Disaster Risk Reduction Management Council (CDRRMC), had passed a resolution dated July 10, 2017 recommending the declaration of a State of Calamity by the City;

WHEREAS, the CDRRMC had also passed another resolution dated July 10, 2017 recommending to this Sanggunian the passage of a resolution authorizing the City Mayor to access and utilize the unexpended balances of the Local Disaster Risk Reduction and Management Fund (LDRRMF) – "A RESOLUTION RECOMMENDING TO THE SANGGUNIANG PANLUNGSOD NG ORMOC THE ISSUANCE OF A RESOLUTION AUTHORIZING THE CITY MAYOR TO ACCESS AND UTILIZE THE UNEXPENDED BALANCES OF THE LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND (LDRRMF)";

WHEREAS, the Office of the City Mayor through an Indorsement dated July 10, 2017 had forwarded to this Sanggunian for its appropriate action the said resolution from the CDRRMC and further requesting that the matter be treated as urgent;

WHEREAS, upon thorough examination by this august Body of said Indorsement by the City Mayor, the same is deemed to be meritorious and deserving of this Sanggunian's prompt and full support for the extreme benefit and welfare it would redound to the City, especially in terms of its relief, rehabilitation and repair efforts post-earthquake for the affected families and damaged structures and properties;

NOW THEREFORE, upon motion made by SP Member Eusebio Gerardo S. Penserga, Chairman, Committee on Public Safety, severally seconded by SP Members Vincent L. Rama, Gregorio G. Yrastorza III, Nolito M. Quilang, John Eulalio Nepomuceno O. Aparis II, Lea Doris C. Villar, Mariano Y. Corro, Benjamin S. Pongos, Jr., Tomas R. Serafica and Rolando M. Villasencio; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a A RESOLUTION AUTHORIZING THE ORMOC CITY MAYOR RICHARD I. GOMEZ TO ACCESS AND UTILIZE THE CITY'S UNEXPENDED BALANCES OF THE LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND (LDRRMF);

ADOPTED, July 10, 2017.
