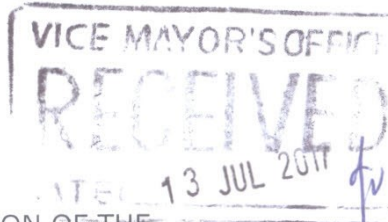

RESOLUTION NO. 2017-155

A RESOLUTION GRANTING AUTHORITY TO THE OIC-TOURISM OFFICER, MR. NELSON L. ALINDOGAN, TO UTILIZE THE CY 2017 APPROPRIATION FOR CAPITAL OUTLAY-MOTOR VEHICLE UNDER THE CITY TOURISM OFFICE IN THE TOTAL AMOUNT OF ONE MILLION NINE HUNDRED THOUSAND PESOS (P1,900,000.00) FOR THE PURCHASE OF ONE (1) UNIT SERVICE VEHICLE.

WHEREAS, the Office of the City Mayor forwarded an Endorsement dated June 15, 2017 to this august Body for consideration, pertaining to the request of Mr. Nelson L. Alindogan, OIC-Tourism Officer, for the utilization of their office appropriation for Capital Outlay-Motor Vehicle in the total amount of ONE MILLION NINE HUNDRED THOUSAND PESOS (P1,900,000.00) for the purchase of one (1) unit service vehicle;

WHEREAS, the City Tourism Office is a vital component of LGU Ormoc in terms of providing quality services and development of economically viable and sustainable tourism programs geared towards the development of city's tourism industry;

WHEREAS, the office plays a key role in information dissemination of the city's tourism potentials as well as the conduct of massive information drive to enhance the capacities of the barangays and other stakeholders for the effective management and development of tourism sites in their area;

WHEREAS, to carry out its mandate, the Tourism Office indeed needs a new service vehicle to achieve a fast and continued services and ensure prompt implementation of its tourism programs and activities;

WHEREAS, the essential funds for the proposed vehicle purchase is available as certified by the OIC-City Accountant and City Budget Officer through a Certificate of Availability of Funds dated June 8, 2017, to be taken from the account – Capital Outlay for Motor Vehicle (Account Code 8710-1-07-06-010) CY 2017 General Fund in the amount of ONE MILLION FOUR HUNDRED THOUSAND PESOS (P1,400,000.00) as authorized by Sangguniang Panlungsod through Appropriation Ordinance No. 2017-001 and from a Supplemental Budget as authorized by the Sangguniang Panlungsod through Appropriation Ordinance No. 2017-003 in the amount of FIVE HUNDRED THOUSAND PESOS (P500,000.00);

FOREGOING PREMISES CONSIDERED, on motion presented by SP Member Benjamin S. Pongos, Jr., Vice-Chairman, Committee on Finance and Appropriation, severally seconded by SP Members Tomas R. RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION GRANTING AUTHORITY TO THE OIC-TOURISM OFFICER, MR. NELSON L. ALINDOGAN, TO UTILIZE THE CY 2017 APPROPRIATION FOR CAPITAL OUTLAY-MOTOR VEHICLE UNDER THE CITY TOURISM OFFICE IN THE TOTAL AMOUNT OF ONE MILLION NINE HUNDRED THOUSAND PESOS (P1,900,000.00) FOR THE PURCHASE OF ONE (1) UNIT SERVICE VEHICLE;
