WHEREAS, he was an acknowledged public servant who served the Senate of the Philippines as Legislative Staff Officer of then Senator Juan Ponce Enrile from 1995 to 1997; Clerk of Court of the Regional Trial Court of Ormoc City from 1997 to 2005; City Prosecutor of the Office of the City Prosecutor, Ormoc City from 2005 to 2009; Acting Legal Officer of the City of Ormoc in 2009; Presiding Judge of the Regional Trial Court, Branch 12, Ormoc City in November 2009, and as Executive Judge of the Regional Trial Court of Ormoc City, covering the administrative jurisdiction of Ormoc City, the Municipalities of Kananga, Matag-ob, Isabel and Merida, Leyte from December 2010 until his demise;

WHEREAS, he served the City of Ormoc with much sincerity and devotion;

WHEREAS, the Sangguniang Panlungsod of Ormoc City mourns the loss of a well-motivated public servant, and so deeply shares the anguish of the bereaved family;

WHEREAS, despite this desolation and bereavement, the constituents of this city take pride and gratitude for his services and contributions, particularly for his integrity and dedication to his work in the judiciary and the justice department which made him the epitome of a true and dedicated public servant, exemplifying transparency in the public service;

WHEREAS, "Clinton", as he was fondly called, had been a man who inspired people from all walks of life and has left a precious legacy of love to his family, dedication and professionalism to his colleagues, kindness to his friends and relatives, and admiration and respect from his constituents;

WHEREAS, because of his dedication and commitment to service, he never wavered nor compromised judicial integrity and efficiency in delivering court services and the City Government of Ormoc will long remember him as the man who embraced the city and poured on his legal expertise, the private citizen who spoke with conviction about the rule of law, and the man who left a shining legacy the Coquilla and Nuevo family would be so proud of;

WHEREAS, this august Body together with the City Officials and the people of Ormoc, grieve his passing and join the entire City in prayer for the eternal repose of his soul, thankful always for his unselfish contributions to the betterment for the City Government of Ormoc and to her people as well;

WHEREAS, the Members of the 14<sup>th</sup> Sangguniang Panlungsod ng Ormoc, its City Officials and all Ormocanons, share the pain and sorrow of the family of the late Hon. James Clinton Richard C. Nuevo, his mother Socorro Coquilla Nuevo, and siblings Jason C. Nuevo, Cynthia N. Camarce, Ma. Liberty N. Dizon, Winston Martial C. Nuevo, Ferdinand Francis C. Nuevo and Rizaldy Brian C. Nuevo as well as that of his other relatives and wish to condole with them in this difficult time;
