RESOLUTION NO. 2017-165

A RESOLUTION AMENDING SP RESOLUTION NO. 2016-103  
SERIES 2016 TITLED: "A RESOLUTION ESTABLISHING AND  
FORMING THE NEW COMPOSITION OF THE PERSONNEL  
SELECTION BOARD (PSB) IN THE CITY GOVERNMENT OF  
ORMOC" BY RECONSTITUTING THE MEMBERS TO THE  
BOARD AND GIVING AUTHORITY TO THE CITY MAYOR, VICE  
MAYOR AND MEMBERS TO DESIGNATE DULY AUTHORIZED  
REPRESENTATIVE IN LIEU OF THEIR ABSENCE OR INABILITY.

WHEREAS, the Sangguniang Panlungsod was in receipt of a communication from the Office of the City Mayor requesting for the amendment of SP Resolution No. 2016-103 which specifically requests to give the City Mayor an authority to designate his authorized representative as Chairman of the Personnel Selection Board and to change the persons comprising the said board;

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, and its Implementing Rules and Regulations, particularly Article 166, Par. (a) and (b) of Rule XXII, mandates for the establishment and constitution of the Personnel Selection Board (PSB) of each city, including this city, to wit:

ART. 166. Personnel Selection Board (PSB) –

- (a) *There shall be established in every province, city or municipality a personnel selection board to assist the local chief executive or, where applicable, the presiding officer of the sanggunian, in the judicious and objective selection of personnel for employment as well as for promotion.*

- (b) *The personnel selection board shall be composed of the local chief executive or his duly authorized representative as chairman, and members to be determined by resolution of the sanggunian concerned in accordance with pertinent civil service law, rules and regulations. A representative of CSC, if any, and the local human resource management officer or his equivalent in the LGU concerned, shall be ex-officio members of the board.*

WHEREAS, the Civil Service Commission (CSC), in line with the above mandate, has also issued Memorandum Circular No. 03, S. 2001 explicitly stating the necessity of establishing a PSB in every agency which will ensure that equal opportunity will be given to each and every applicant aspiring for any job and prescribing the composition thereof;

WHEREAS, the PSB, once created, will be tasked to formulate and initiate innovative schemes in conformity with existing laws and relevant regulations which will then serve as basis in deliberating all applicants to any vacant positions in the City Government and that of the future promotions of city employees, results of any personnel deliberation conducted by the board shall be subject to the assessment and sound discretion of the appointing authority;

WHEREAS, in pursuance of the Local Government Code of 1991 and its aforementioned applicable provisions in the Implementing Rules and Regulations, and related Civil Service policy, and on the letter of the City Mayor dated March 2, 2017 that requested this Sanggunian for the passage of a resolution amending SP Resolution 2016-103 and modifying the composition of the PSB of the City Government of Ormoc which is to be composed of the following members:
