RESOLUTION NO. 2017-171

A RESOLUTION GRANTING AUTHORITY TO ORMOC CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), WITH THE DEPARTMENT OF HEALTH -REGIONAL OFFICE VIII (DOH-RO VIII) FOR THE IMPLEMENTATION OF THE INTEGRATED CLINIC INFORMATION SYSTEM (iClinicSys).

WHEREAS the Office of the City Mayor submitted to this august Body an Indorsement dated July 14, 2017, requesting for the passage of a resolution granting authority to the City Mayor Richard I. Gomez to enter into and sign for and on behalf of LGU-Ormoc, a Memorandum of Agreement (MOA) with the DOH-Regional Office VIII for the implementation of Integrated Clinic Information System (iClinicSys), a copy of the MOA is hereto attached and made an integral part hereof;

WHEREAS, iClinicSys is an electronic medical record and health information system developed by the DOH for primary health care facilities that satisfies Philippine Health Insurance Corporation requirements for benefit packages through capitation and DOH Reporting necessities including national health data standards;

WHEREAS, the system is provided free to interested primary health care facilities including the training and technical support if needed, subject to compliance of certain health information interoperable standards and other related conditions to be imposed prior to its implementation;

WHEREAS, LGU-Ormoc desires to implement and use the iClinicSys alongside the provision of health services to Ormoc City constituents to help manage the patients' demographics, medical histories, diagnoses, treatments, medications, laboratory requests and results, and generate the required data for their own use and also for submission to DOH and PhilHealth;

WHEREAS, with this desire is also the commitment of LGU-Ormoc to comply all requirements and abide with all applicable laws, rules and regulations related to iClinicSys;

WHEREAS, this Sanggunian finds the iClinicSys as an innovative information system which is very useful in terms of storing and managing medical records and other related health documents responsive to the needs of the present times therefore, most beneficial to the city in its effort to strengthen and achieve a fast and efficient public service; and further, this Body, upon close and thorough evaluation of the MOA also finds the stipulations contained therein to be in order and the obligations imposed on both parties are doable therefore, most deserving of full support;

WHEREFORE, on joint motion of SP Member Mario M. Rodriguez, Chairman, Committee on Health and Sanitation and SP Member Vincent L. Rama, Member, Committee on Laws & Ordinances, severally seconded by SP Members Tomas R. Serafica, Benjamin S. Pongos, Jr., Gregorio G. Yrastorza III, Nolito M. Quilang, Lea Doris C. Villar and Mariano Y. Corro; be it
