RESOLUTION NO. 2017-174

A RESOLUTION AUTHORIZING THE CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN THE LETTER OF AGREEMENT FOR AND IN BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) WITH THE AGRICULTURE TRAINING INSTITUTE REGIONAL TRAINING CENTER VIII (ATI-RTC VIII), FOR THE "ENHANCEMENT OF FARMERS INFORMATION TECHNOLOGY SERVICES (FITS) CENTER UNDER THE RICE CROP MANAGER.

WHEREAS, the 14th Sangguniang Panlungsod ng Ormoc received an endorsement letter from the Office of the City Mayor dated July 31, 2017 endorsing a request from the City Agriculture Office for the passage of a resolution authorizing the City Mayor Richard I. Gomez to enter into and sign the Letter of Agreement for and in behalf of the Local Government Unit of Ormoc (LGU-Ormoc) with the Agriculture Training Institute Regional Training Center VIII (ATI-RTC VIII), for the project "Enhancement of Farmers Information Technology Services (FITS) Center Under The Rice Crop Manager;

WHEREAS, Executive Order No. 801 dated May 14, 2009, the Department of Agriculture is mandated to provide extension services to local government units through its extension and training arm Agriculture Training Institute and, on the other hand encourages LGUs to adopt this services through a fast-track technology delivery about agriculture, fisheries and natural resources under the *Techno Gabay* program and one of its components is the Farmers Information Technology Services (FITS);

WHEREAS, this Farmers Information Technology Services (FITS) provides information, technologies and other services on agriculture, that is, the Rice Crop Manager. The Rice Crop Manager is a method of providing personalized fertilizer recommendation to rice farmers in rainfed and irrigated areas, through a computer generated information source on rice farming;

WHEREAS, on January 31, 2007 LGU-Ormoc has entered into and signed the Memorandum of Agreement with the Agriculture Training Institute Regional Training Center VIII (ATI-RTC VIII) with other sectors to adopt this program;

WHEREAS, in a letter dated July 24, 2017, the City Legal Officer suggested for Sangguniang Panlungsod Resolution be secured to give authority to the City with respect to this matter. After he reviewed the Letter of Agreement (LOA) with the provisions of E.O. 801 and its Implementing Rules and Regulations (IRR) as well as the said MOA, thus, he finds that the LOA is not detrimental to the interest of the City, not contrary to law, moral and public policy;

WHEREAS, this Sanggunian finds that the aforementioned request by the City Mayor is advantageous and for the best interest of the City and its inhabitants, especially the rice farmers, students, researchers and to the community;

NOW, THEREFORE, on joint motion of SP Member Tomas R. Serafica, Chairman of the Committee on Agriculture & Fisheries and SP Member Benjamin S. Pongos, Jr., Chairman, Committee on Laws & Ordinances, severally seconded by SP Members Vincent L. Rama, Gregorio G. Yrastorza III, Nolito M. Quilang, Lea Doris C. Villar and Mariano Y. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION AUTHORIZING THE CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN THE LETTER OF AGREEMENT FOR AND IN BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) WITH THE AGRICULTURE TRAINING INSTITUTE REGIONAL TRAINING CENTER VIII (ATI-RTC VIII), FOR THE "ENHANCEMENT OF FARMERS INFORMATION TECHNOLOGY SERVICES (FITS) CENTER UNDER THE RICE CROP MANAGER;
