RESOLUTION NO. 2017-176

A RESOLUTION EARNESTLY SEEKING FINANCIAL ASSISTANCE AND SUPPORT FROM THE 17TH CONGRESS OF THE HOUSE OF REPRESENTATIVES THROUGH FOURTH CONGRESSIONAL DISTRICT OF LEYTE REPRESENTATIVE LUCY MARIE TORRES-GOMEZ, FOR THE REPAIR AND IMPROVEMENT OF THE FACILITIES, ROADS, AND OTHER INFRASTRUCTURES OF THE LAKE DANAOS NATURAL PARK LOCATED IN BARANGAY LAKE DANAOS, THIS CITY.

WHEREAS, this august Body was in receipt of an Indorsement from the Office of the City Mayor dated August 11, 2017, requesting therein for the passage of a resolution seeking financial assistance and support from the 17th Congress of the House of Representatives through Fourth Congressional District of Leyte Representative Lucy Marie Torres-Gomez, for the repair and improvement of the facilities of the Lake Danaos Natural Park, a list of the subject facilities is hereto attached and made an integral part hereof;

WHEREAS, Lake Danaos, considered as a main natural attraction and a reliable source of much-needed tourism revenues and employment for both the Barangay and City, is a violin-shaped lake located in Barangay Lake Danaos, this City, covering an area of 148 hectares and is approximately 600 meters above sea level;

WHEREAS, Lake Danaos Natural Park which covers a total area of 2,193 hectares, is one of the seven protected areas in Eastern Visayas declared under the National Integrated Protected Area System (NIPAS) Act of 1992;

WHEREAS, to recall, on or about four o'clock (4:00) in the afternoon of July 6, 2017, the City of Ormoc was struck by a 6.5 Magnitude Earthquake causing massive damage not only to its infrastructure but to its environment as well;

WHEREAS, the 6.5 Magnitude earthquake and the succeeding aftershocks which often were quite strong in themselves, had caused various landslides, damaged roads, concrete or otherwise, produced massive ground cracks, and caused other forms of devastation within and around the vicinity of the protected area of the Lake Danao Natural Park;

WHEREAS, by reason of foregoing premises, this Sanggunian indeed finds meritorious and deserving of considerable support the City Mayor's aforementioned Indorsement for the passage of a resolution earnestly requesting the 17th Congress of the House of Representatives through Fourth Congressional District of Leyte Representative Lucy Marie Torres-Gomez for financial assistance and other forms of essential support for the prompt and full repair and improvement of the facilities, roads, and other infrastructures of the Lake Danao Natural Park;

WHEREAS, additionally this Sanggunian finds that the favorable granting and extension of the sought assistance and support will also equip and enable the City to employ and adopt sustainable development measures, and implement adaptation and disaster-mitigation strategies in Lake Danao Natural Park, with emphasis on environmental protection and awareness;

WHEREFORE, on MASS MOTION of the Body; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION EARNESTLY SEEKING FINANCIAL ASSISTANCE AND SUPPORT FROM THE 17TH CONGRESS OF THE HOUSE OF REPRESENTATIVES THROUGH FOURTH CONGRESSIONAL DISTRICT OF LEYTE REPRESENTATIVE LUCY MARIE TORRES-GOMEZ, FOR THE REPAIR AND IMPROVEMENT OF THE FACILITIES, ROADS, AND OTHER INFRASTRUCTURES OF THE LAKE DANAOS NATURAL PARK LOCATED IN BARANGAY LAKE DANAOS, THIS CITY;
