RESOLUTION NO. 2017-181

A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ, FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC CITY (LGU-ORMOC), TO ACCEPT AND SIGN THE DEED OF DONATION EXECUTED BY SPOUSES FELIX ARANETA AND AMALIA MAJADAS, ANTONIO ARANETA AND NELEN DONDOYANO, ANACLETO ARANETA, JR. AND VIVIAN ESTREMOS, AND JESSIE ARANETA AND LAILA DELA CERNA, AS DOMORS, OF A PARCEL OF LAND LOCATED IN BARANGAY LICUMA, THIS CITY, COVERED BY TRANSFER CERTIFICATE OF TITLE (TCT) NO. 121-20140001836 AND DENOMINATED AS LOT NO. 3 OF PLAN NO. PCS-08-001317-D, IN FAVOR OF LGU-ORMOC AS DONEE.

WHEREAS, this august Body was in receipt of an Indorsement from the Office of the City Mayor dated August 02, 2017, requesting therein for the passage of a resolution granting authority to Ormoc City Mayor Richard I. Gomez to accept and sign, for and on behalf of LGU-Ormoc the Deed of Donation made and executed by Spouses Felix Araneta and Amalia Majadas, Antonio Araneta and Helen Dondoyano, Anacleto Araneta, Jr. and Vivian Estremos, and Jessie Araneta and Laila Dela Cerna, as Donors of a parcel of land in favor of the LGU-Ormoc as Donee, a copy of said Deed of Donation is hereto attached and made an integral part thereof;

WHEREAS, the Donors are owners of a parcel of land located at Barangay Licuma, this City, which were particularly described in the Narrative Technical Description and more particularly described as follows:

"Transfer Certificate of Title No. 121-2014001836

A parcel of land (Lot 3 plan PCS-08-001317-D, being a portion of Lot 6456-B, PSD-08-0211-87 (RA); Lot 6456-A, PSD-08-0211-87 (AR); Lot 6456-C, PSD-08-021187 (AR)), with improvements thereon situated at Brgy. Licuma, City of Ormoc, Province of Leyte, containing a total area of One Thousand Two Hundred (1,200) square meters, more or less, registered in the name of Spouses Felix Araneta and Amalia Majadas, Antonio Araneta and Helen Dondoyano, Anacleto Araneta, Jr. and Vivian Estremos, and Jessie Araneta and Laila Dela Cerna, all of legal age, Filipinos";

WHEREAS, as cited in the Deed of Donation, the Donors freely and voluntarily give, transfer and convey by way of donation unto Donee (LGU-Ormoc) a parcel of land containing a total area of One Thousand Two Hundred (1,200) square meters;

WHEREAS, this august Body believes that said donation is done in good faith, extremely beneficial to the Barangay and to the City in general, and not made for the purpose of defrauding their creditors, having reserved for themselves enough and sufficient property to meet their obligations:

WHEREAS, the said donated property shall be considered as forming part of City properties for public use pursuant to the applicable provisions of the Civil Code;

WHEREAS, this Sanggunian, after thorough examination of the aforementioned request by the City Mayor finds that it is to the best interest of the City and advantageous to the same to authorize the City Mayor to sign the Deed of Donation and accept the said property located at Barangay Licuma, this City;
