WHEREAS, The City of Ormoc was struck by an earthquake last July 6, 2017 at 4:06 in the afternoon which has left 1,321 families from various barangays displaced from their homes;

WHEREAS, in line with their desire to extend financial assistance to the City of Ormoc, the Sangguniang Panlungsod Members of the City of Mandaue has passed a resolution numbered as Resolution No. 14-545-2017, entitled: "Granting Financial Assistance to the Earthquake Victims of Ormoc City in the amount of One Hundred Thousand Pesos (P100,000.00)";
