RESOLUTION 2017-201

A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) WITH THE DEPARTMENT OF AGRICULTURE, REGIONAL FIELD OFFICE NO. 8 (DA-RFO 8), REPRESENTED BY ITS OIC-REGIONAL EXECUTIVE DIRECTOR, U-NICHOLS A. MANALO, FOR THE PROVISION OF ONE (1) UNIT COMPACT CORN MILL UNDER THE CORN PROGRAM/CASSAVA PROJECT CY 2017 THROUGH A FULL GRANT FINANCING SCHEME FROM THE DEPARTMENT OF AGRICULTURE (DA).

WHEREAS, an Endorsement dated August 29, 2017 from the Office of the City Mayor was issued to this august Body for consideration, relative to the preceding Endorsement from the Acting City Agriculturist, Maria Elena A. Mendoza, regarding the MOA to be entered into by LGU-Ormoc, with the Department of Agriculture, Regional Field Office No. 8 (DA-RFO 8), and further requesting authority for the City Mayor Richard I. Gomez to sign the same for and on behalf of LGU-Ormoc, a photocopy of the MOA is hereto attached and made an integral part hereof;

WHEREAS, the MOA deals with the provision of one (1) unit Compact Corn Mill under the Corn Program/Cassava Project CY 2017 through a full grant financing scheme to LGU-Ormoc from the Department of Agriculture which is deemed helpful in the modernization of farm operations by mechanizing farming activities and contributing to the corn production in the city;

WHEREAS, DA-RFO 8 as the implementing arm of the Department of Agriculture, is mandated to provide support and assistance to LGUs in their pursuit of agriculture development and the promotion of farmers' welfare;

WHEREAS, to modernize the agriculture and fisheries sector by transforming them from a resourced-based to a technology-based industry is among the objectives of the Agriculture and Fisheries Modernization Act (AFMA);

WHEREAS, the provision of Compact Corn Mill is one of the components of the Corn Program and the availment of LGU-Ormoc of the Corn Mill will help in achieving the goals of modernizing the farm operations in Ormoc City specifically the corn farming for a more improved production;

WHEREAS, LGU-Ormoc – City Agriculture Office, in its desire to upgrade and modernize farming activities and develop the City's corn production signified its intention to avail of one (1) unit Compact Corn Mill amounting to Three Hundred Fifty Thousand Pesos (Php350,000.00) through a full grant financing scheme from the Department of Agriculture;

WHEREAS, the parties thereto have agreed to perform committedly their therein described roles and obligations regarding the provision of one (1) unit Compact Corn Mill, and upon close and thorough review of the MOA by the City Legal Office, the same was found to be in order, not detrimental to the interest of the city, not contrary to law, morals and public policy, and so therefore, is most worthy of this august Body's prompt favorable consideration and support;

WHEREFORE, on joint motion of SP Member Tomas R. Serafica., Chairman, Committee on Agriculture & Fisheries and SP Member Benjamin S. Pongos, Jr., Chairman, Committee on Laws & Ordinances, severally seconded by SP Members Mariano Y. Corro, Lea Doris C. Villar, John Eulalio Nepomuceno O. Aparis II, Gregorio G. Yrastorza III and Eusebio Gerardo S. Penserga; be it


RESOLVED, FURTHER, that a copy of the final and notarized Memorandum of Agreement (MOA) be furnished to this Sanggunian for its information and files;


