## RESOLUTION NO. 2017-204

RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR GOMEZ TO ENTER INTO AND SIGN THE REVISED TERMS OF PARTNERSHIP FOR AND ON BEHALF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-PRMQC), WITH THE DEPARTMENT OF HEALTH - REGIONAL OFFICE VIII (DOH-RO VIII) REPRESENTED BY DIRECTOR MINERVA P. MOLON, FOR THE MANAGEMENT AND IMPLEMENTATION OF THE LOCAL INVESTMENT PLAN FOR HEALTH (LIPH) 2017-2019 THROUGH THE APPROVED ANNUAL OPERATIONAL PLAN (AOP) 2017 OF LGU- ORMOC THEREBY, SUPERSEDING SP RESOLUTION NO 2017-170 OF THIS SANGGUNIAN.

WHEREAS, this Sanggunian received an Endorsement from the Office of the City Mayor dated September 5, 2017 relative to the Revised Terms of Partnership by and between the LGU-Ormoc and the DOH-Regional Office VIII, for the management and implementation of the Local Investment Plan for Health (LIPH) 2017-2019 through the approved Annual Operational Plan (OAP) 2017 of LGU-Ormoc and further requesting for urgent action thereof;

WHEREAS, to recall, this Body had already passed a resolution granting the City Mayor the necessary authority to enter into and sign the Terms of Partnership for the implementation of 2017-2019 LIPH denominated as SP Resolution No. 2017-170 dated August 3, 2017;

WHEREAS, it was later found out that the previously approved Terms of Partnership needs some amendments considering that there were provisions under the Roles and Responsibilities on the part of the LGU/City which were inadvertently missed but are deemed indispensable in achieving the desired results of the LIPH implementation;

WHEREAS, the subject Revised Terms of Partnership has passed through the Office of the City Legal Officer for proper review and at the instance, the City Legal Officer, Atty. Jasper M. Lucero issued a statement that the same is in order, not detrimental to the interest of the city, not contrary to law and public policy;

WHEREAS, as emphasized the LIPH is the key instrument in forging the DOH and LGU-Ormoc partnership to carry out the Three (3) guarantees of the Philippine Health Agenda (PHA) for 2016-2022 which were anchored on the theme "All for Health toward Health for All" namely: 1.) Quality services for both the sick and the well, for all life stages and triple burden of disease, 2.) Functional service delivery networks; and, 3.) Universal health insurance, in order to attain-health related Sustainable Development Goals (SDGs), financial risk protection, better health outcomes and responsiveness;

WHEREAS, LIPH is a medium range plan that covers the period 2017-2019 based on the actual situation of the city and will serve as a vehicle in implementing and consolidating support for health reforms at the city level. From this plan, the AOP 2017 of LGU-Ormoc was crafted out consolidating therein the priority programs and activities, as well as health strategies that will be undertaken and implemented by the Six (6) District Health Centers of the City for the current year;

WHEREAS, LGU-Ormoc agrees to implement health sector reforms consistent with the PHA 2016-2022 and has proven its capacity to utilize investment and sustain the reform process and likewise, to fund the programs, projects and activities under the LIPH through own financing sources, and through available funds from development partners which should be coordinated with the DOH;

WHEREAS, to formalize and confirm the commitment of LGU-Ormoc and DOH-RO VIII, the parties collaborates to enter into this partnership for the effective and efficient delivery of health services and facilities, likewise to adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and social services available to all people at affordable cost as mandated in the 1987 Philippine Constitution and the 1991 local Government Code:

WHEREAS, upon close and thorough review of the Revised Terms of Partnership, this august Body finds that it is just and does not contain any previsions that may adversely affect the interest of the city and overall, is truly beneficial to LGU-Ormoc therefore, most deserving of full support and affirmative action,

WHEREFORE, on joint motion of SP Member Mario M. Rodriguez, Chairman, Committee on Health and Sanitation and SP Member Benjamin S. Pongos, Jr., Chairman, Committee on Laws & Ordinances, severally seconded by SP Members Mariano Y. Corro, Lea Doris C. Villar, John Eulalio Nepomuceno O. Aparis II, Gregorio G. Yrastorza III and Tomas R. Serafica; be it
