RESOLUTION NO. 2017-206

A RESOLUTION EARNESTLY SEEKING FINANCIAL ASSISTANCE AND SUPPORT FROM THE TOURISM INFRASTRUCTURE AND ENTERPRISE ZONE AUTHORITY (TIEZA), FOR THE CONVERSION OF THE OLD ORMOC CITY HALL INTO A CITY MUSEUM, AND FURTHER AUTHORIZING CITY MAYOR RICHARD I. GOMEZ TO MAKE THE PROPER REPRESENTATIONS WITH TIEZA, FOR AND IN BEHALF OF THE CITY OF ORMOC

WHEREAS, this august Body was in receipt of an Indorsement from the Office of the City Mayor dated September 11, 2017, requesting therein for the passage of a resolution seeking financial assistance and support from the Tourism Infrastructure And Enterprise Zone Authority (TIEZA), for the conversion of the Old Ormoc City Hall into a museum, and further authorizing City Mayor Richard I. Gomez to make the proper representations with TIEZA, for and in behalf of the City Of Ormoc, further classifying the same as EXTREMELY URGENT;

WHEREAS, TIEZA is a public corporate body which is mandated to develop, manage, and supervise tourism infrastructure projects in the country;

WHEREAS, TIEZA's thrust to invest in Tourism Enterprise Zones particularly states that, "the project should involve development, rehabilitation and enhancement of tourism historic sites, cultural and heritage sites, and ecotourism sites";

WHEREAS, to recall, this Sanggunian enacted Ordinance No. 06 Series of 2016 declaring the Old Ormoc City Hall as a city cultural property of the City of Ormoc;

WHEREAS, it is the City's objective to establish an institution that will cherish and care for cultural heritage, artifacts, arts, books, documents, objects and items, particularly, among others, those with historical significance, scientific invention and discoveries that will serve its strategic development;

WHEREAS, towards these thrusts, the City aims to collect and preserve objects and items of historical or cultural value or discoveries, which shall be open for exhibition to the general public through the establishment of a City Museum;

WHEREAS, by reason of foregoing premises, this Sanggunian indeed finds meritorious and deserving of considerable support the City Mayor's aforementioned Indorsement requesting for the passage of a resolution earnestly requesting the TIEZA for the conversion of the Old Ormoc City Hall into a museum, and further authorizing City Mayor Richard I. Gomez to make the proper representations with TIEZA, for and in behalf of the City Of Ormoc;

WHEREAS, additionally this Sanggunian finds that the favorable granting and extension of the sought assistance and support will also equip and enable the City to adopt its economic and social advancement through its firm and steadfast principle and policy that the cultural and historical heritage of Ormoc should not be sacrificed;

WHEREFORE, on motion of SP Member Benjamin S. Pongos, Jr., Vice Chairman, Committee on Tourism, severally seconded by SP Members Mariano Y. Corro, John Eulalio Nepomuceno O. Aparis II, Gregorio G. Yrastorza III and Tomas R. Serafica; be it


