

RESOLUTION NO. 2017-207

A RESOLUTION APPROVING THE APPLICATIONS FOR ACCREDITATION WITH THE LOCAL GOVERNMENT UNIT OF ORMOC, IN ACCORDANCE WITH THE PROVISIONS OF ORDINANCE NO. 009 DATED OCTOBER 16, 2014 OF THE FOLLOWING CIVIL SOCIETY ORGANIZATIONS, TO WIT:

1. SALVACION ORGANIC FARMERS ASSOCIATION (SOFA)
2. KABABAYAN RIDERS ASSOCIATION FOR A NEW CULTURAL HARMONY AND ORDER, INCORPORATED (KARANCHO INC.)

WHEREAS, this Sanggunian was in receipt of the applications of SALVACION ORGANIC FARMERS ASSOCIATION (SOFA) and KABABAYAN RIDERS ASSOCIATION FOR A NEW CULTURAL HARMONY AND ORDER, INCORPORATED (KARANCHO INC.), both Civil Society Organizations (CSOs) seeking for accreditation with the Local Government Unit of Ormoc;

WHEREAS, SALVACION ORGANIC FARMERS ASSOCIATION (SOFA), is a legitimate workers association composed of farmers residing in Brgy. Salvacion, Ormoc City and registered under the Department of Labor and Employment. The association was established for the mutual aid and protection of its members. Among its objectives is to work with non-government organizations and government entities for the promotion and development of the association;

WHEREAS, KABABAYAN RIDERS ASSOCIATION FOR A NEW CULTURAL HARMONY AND ORDER, INCORPORATED (KARANCHO INC.), is a non-stock, non-partisan and non-sectarian volunteer organization registered with the Securities and Exchange Commission, constituted by the motorcycle owners geared towards Community Assistance and Development Program of the PNP. The organization is coherent to the bondage of "Respect One Another" and firmly believes that the restoration of our neglected cultural values can be strengthened. Among its purposes is to become an effective conduit of the government and private sectors and NGO's in carrying assistance projects and programs designed to promote and uplift the general welfare and interest of the community;

WHEREAS, it can be recalled that this Sanggunian has enacted Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, Section 2.1 of Ordinance No.009 provides among others that an organization may still be accredited after the prescribed sixty (60) – day period within which application for accreditation shall be accepted, for purposes other than representation to local special bodies;

WHEREAS, after close and thorough review of the aforementioned applications, this Sanggunian finds that the same are in order, and the purposes of the sought accreditation are all directed to promote mutual aid, protection, and socio-economic development among its members as well as to establish a strong linkage with the LGU and actively participate in the implementation of the diverse programs and projects of the government to promote inclusive growth;

WHEREAS, further, this august Body deem the applications to be lawful being in accordance with the provisions of Ordinance No. 009 hence, most deserving of favorable action by this Sanggunian;

WHEREFORE, on motion of SP Member Eusebio Gerardo S. Penserga, Chairman, Committee on Accreditation, severally seconded by SP Members Vincent L. Rama, Tomas R. Serafica, John Eulalio Nepomuceno O. Aparis II, Lea Doris C. Villar, Gregorio G. Yrastorza III, Mariano Y. Corro and Benjamin S. Pongos, Jr.; be it


