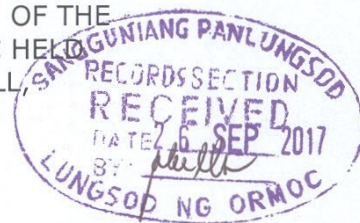

RESOLUTION NO. 2017-217

A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) WITH ROBINSONS LAND CORPORATION FOR THE OPERATION OF THE ORMOC CITY NORTH TRANSPORT TERMINAL LOCATED AT ROBINSON'S MALL, LILIA AVENUE, BRGY. COGON, THIS CITY.

WHEREAS, an Indorsement was forwarded to this august Body from the Office of the City Mayor requesting authority to enter into and sign the MOA with Robinson's for the operation of the bus terminal located at Robinson's Mall, Lilia Avenue, Brgy. Cogon, Ormoc City, a photocopy of the final MOA is hereto attached and made an integral part hereof;

WHEREAS, this Sanggunian passed City Ordinance No. 035, Series of 2017, otherwise known as the Ormoc City North Transport Terminal Ordinance of 2017, with the main purpose of easing traffic congestion in the main thoroughfares of the city and providing the public of a regulated, systematic, convenient, safe and comfortable public terminal;

WHEREAS, Robinsons Land Corporation, one of the Philippines' leading real estate companies, which is also involved in the development and operation of shopping malls and hotels has decided to construct a Robinson's Place Ormoc, a massive shopping mall in Brgy. Cogon, Ormoc City along with the construction of a modern and adequate public transport terminal in their mall's premises with the construction costs all at their account, and subsequently, bestow upon the City the sole function and responsibility of operating the same at no cost at all to the latter;

WHEREAS, the City of Ormoc is quite fortunate and accepts the gesture offered by Robinsons to manage, supervise and regulate the day to day operations of the Ormoc City North Transport Terminal located in Lilia Avenue, Brgy. Cogon, this City;

WHEREAS, the City of Ormoc is becoming a rapidly developing locality characterized by: unprecedented increases in the number of PUVs serving various routes and destinations; incessant mobility and influx of people, local or otherwise; and, steady increases in civilian population thereby necessitating a solution directed towards easing this up thru the establishment of the Ormoc City North Transport Terminal;

WHEREAS, there is a need to pass a resolution authority to the City Mayor to enter and sign for and on behalf of the Local Government Unit of Ormoc to enter into a MOA with Robinsons Land Corporation so as to facilitate the swift and smooth operation, management and regulation of the Ormoc City North Transport Terminal;

WHEREAS, the parties thereto have agreed to perform committedly their therein described roles and responsibilities subject of the MOA;

WHEREAS, the subject MOA clearly and plainly encapsulates the terms and conditions of the agreement of the parties thereto, including their specific roles and obligations towards the attainment of the lofty ends of the same, and this Sanggunian, upon thorough review, finds that overall it is favorable and advantageous to all Ormocanons to address the traffic problems and congestion that the City and its inhabitants are experiencing, and therefore, is most deserving of this august Body's prompt and favorable consideration;

WHEREFORE, on motion of SP Member Benjamin S. Pongos Jr., Chairman, Committee on Laws and Ordinances, severally seconded by SP Members Vincent L. Rama, Tomas R. Serafica, Eusebio Gerardo S. 
RESOLVED, FURTHER, that a copy of the final and notarized Memorandum of Agreement (MOA) be furnished to this Sanggunian for its information and files;
