RESOLUTION NO. 2017-218

A RESOLUTION APPROVING THE PURCHASE OF ONE (1)
UNIT BRAND NEW REFRIGERATED MEAT VAN FOR ORMOC
CITY SLAWSHTERHOUSE OFFICE USE.

WHERIAS, an Endorsement dated September 11, 2017 from the City Mayor Richard I. Gomez was received by this august Body relative to the request of Mr. Cristeto F. Manoras, Slaughterhouse Master II, Ormoc City Slaughterhouse Office, to purchase One (1) Unit Brand New Refrigerated Meat Van for Slaughterhouse Office use;

WHEREAS, the proposed procurement of Refrigerated Meat Van is deemed vital to the improvement of day to day operation of the Slaughterhouse considering that at present the office is in position of only two (2) units of Meat Van which are clearly not enough to respond to the daily transportation utility requirements of the said office;

WHEREAS, per information gathered from Mr. Mandras, their current problem on transport utility has compounded because One (1) of the Meat Vans they have right now is already not in good running condition due to wear and tear being acquired way back in 1999 yet, thus, needs possible repairs and maintenance;

WHEREAS, the need to purchase additional Meat Van for Slaughterhouse Office use is indeed an immediate concern that has to be addressed for the efficient and effective day to day operation of said office and to ensure that there is uninterrupted delivery of public service especially, with the current situation wherein there is a considerable increase of the current number of pigs and cattle entered daily into the Slaughterhouse following the strict enforcement of City Ordinance No. 61, S. 1997 which firmly prohibits the peddling and selling of meats of pigs and cattle slaughtered outside the Ormoc City Slaughterhouse;

WHEREAS, the necessary funds to cover the proposed purchase of One (1) unit brand new Refrigerated Meat Van estimated to cost TWO MILLION NINE HUNDRED TWENTY ONE THOUSAND NINE HUNDRED NINETY FIVE PESOS (P2,921,995.00) are available as certified by the City Budget Officer and the OIC-City Accountant through a Certificate of Availability of Funds dated August 7, 2017 to be taken from the General Fund account- Capital Outlay for Motor Vehicles of the Ormoc City Slaughterhouse Office specifically from the following, to wit:
