## RESOLUTION NO. 2017-22

A RESOLUTION RATIFYING AND CONFIRMING THE ACT OF MAYOR RICHARD I GOMEZ IN ENTERING INTO AND SIGNING THE MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BENALF OF THE LOCAL GOVERNMENT UNIT OF ORMOS (I.G.) ORMOC) WITH PULP SPECIALTIES PHILIPPINES INC. (PSPI) FOR THE FORMER TO BORROW TWO (2) UNITS 333 KVA TRANSFORMERS FROM THE LATTER TO BE USED IN THE ORMOC CITY SUPERDOME LAST SEPTEMBER 14, 2017.

WHEREAS, the City Mayor Richard I. Gomez through an Indorsement dated September 20, 2017 forwarded to this august Body for consideration the Memorandum of Agreement entered into by LGU-Ormoc with PSPI dated September 13, 2017 (Doc. No. 312, Page No. 63, Book No. 45, Series of 2017), further requesting this Sanggunian to ratify and authorize the City Mayor to execute the same, further classifying the same as EXTREMELY URGENT, a copy of the notarized MOA is hereto attached and made an integral part hereof;

WHEREAS, a MOA was signed into by and between the LGU-Ormoc represented by the City Mayor Richard I. Gomez and the PSPI represented by Plant Manager, Ms. Lidia Duran last September 13, 2017 for the borrowing of 2 units of 333 KVA transformers which PSPI owns to be used by LGU-Ormoc in the Ormoc City Superdome for an activity held last September 14, 2017;

WHEREAS, in a communication dated September 18, 2017 sent by City Legal Officer, Atty. Jasper M. Lucero, it states that the said MOA was executed without the corresponding authority from the Sanggunian as it was very urgent to borrow the 2 units of 333 KVA transformers immediately which were badly needed in the Superdome last September 14, 2017;

WHEREAS, due to the immediate need and urgency of the need to borrow aforesaid transformers, the City Mayor signed the MOA with PSPI;

WHEREAS, an authority for the City Mayor to enter into and sign the MOA for and on behalf of the City Government is but indispensable;

WHEREAS, the subject MOA, upon further examination, is found to clearly and plainly encapsulate the terms and conditions of the agreement of the parties thereto, including their specific roles and obligations;

WHEREAS, upon close and thorough review, this Sanggunian, finds that the MOA is not contrary to law and existing contracts and deems that it is of the best interest of the City that the said act of the City Mayor be ratified so therefore, most deserving of this august Body's full support and affirmative action to the same.
