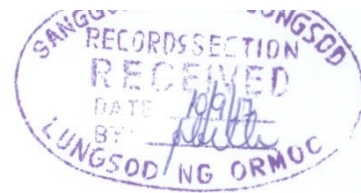

RESOLUTION 2017-224

A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) WITH THE DEPARTMENT OF AGRICULTURE, REGIONAL FIELD OFFICE NO. 8 (DA-RFO 8), REPRESENTED BY ITS OIC-REGIONAL EXECUTIVE DIRECTOR, U-NICHOLS A. MANALO, FOR THE PROVISION OF ONE (1) UNIT MECHANICAL CORN SHELLER UNDER THE CORN PROGRAM/CASSAVA PROJECT CY 2016 THROUGH A FULL GRANT FINANCING SCHEME FROM DEPARTMENT OF AGRICULTURE (DA).

WHEREAS, this Sanggunian received an urgent Endorsement from the Office of the City Mayor dated September 22, 2017 in connection with the preceding Endorsement from the Acting City Agriculturist, Maria Elena A. Mendoza, requesting for an immediate passage of a resolution granting City Mayor Richard I. Gomez the authority to enter into and sign the MOA by and between LGU-Ormoc, with the Department of Agriculture-Regional Field Office VIII (DA-RFO VIII), a photocopy of the MOA is hereto attached and made an integral part hereof;

WHEREAS, the MOA refers to the provision of Mechanical Corn Sheller under the Corn Program/Cassava Project CY 2016 through a full grant financial scheme from DA to LGU Ormoc which aim is to transform corn farm clusters into modern agribusiness system thru mechanized farming;

WHEREAS, in pursuit of poverty alleviation in the agricultural sector and food security, the Department of Agriculture through its Regional Field Office is implementing the Corn Program/Cassava Project for agriculture development and the promotion of farmers' welfare;

WHEREAS, among the objectives of the Agricultural and Fisheries Modernization Act (AFMA) is to modernize the agriculture and fisheries sectors by transforming them from a resourced-based to technology-based industry;

WHEREAS, the provision of Mechanical Corn Sheller is one of the components of the corn program that will help in the modernization of farm operations by mechanizing farming activities and contributing to the corn production;

WHEREAS, LGU-Ormoc - City Agriculture Office desires to enhance and modernize farming activities and develop the corn production in Ormoc City and towards this end, signified its intention to avail of one (1) unit Mechanical Corn Sheller amounting to One Hundred Twenty Thousand Pesos (Php120,000.00) through a full grant financing scheme from the Department of Agriculture;

WHEREAS, the parties to the MOA have agreed to perform committedly their therein described roles and obligations towards the provision of subject Mechanical Corn Sheller and upon close and thorough review by the City Legal Officer of the MOA, the same was found to be in order, not detrimental to the interests of the city, not contrary to law, morals and public policy, and so therefore, most deserving of this august Body's full support and affirmative action;

WHEREFORE, on motion of SP Member Nolito M. Quilang, Vice Chairman, Committee on Laws & Ordinances, severally seconded by SP Members Mariano Y. Corro, Lea Doris C. Villar, John Eulalio Nepomuceno O. Aparis II, Gregorio G. Yrastorza III and Eusebio Gerardo S. Penserga; be it
