A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN THE ENTERTAINMENT CONTRACT, FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), WITH APRIL BOY REGINO REPRESENTED BY ITS MANAGER MADELYN REGINO FOR THE ORMOC CHARTER DAY CELEBRATION ON OCTOBER 20, 2017.

WHEREAS, this august Body was in receipt of an urgent request from the Office of the City Mayor, requesting therein for the passage of a resolution granting the City Mayor Richard I. Gomez, authority to enter into and sign the Entertainment Contract by and between the LGU – Ormoc and Madelyn Regino, a photocopy of the final Entertainment Contract is hereto attached and made an integral part hereof;

WHEREAS, the parties have agreed that LGU-Ormoc, the Producer, will engage the services of April Boy Regino, the Artist, where the latter will perform a live band show on October 20, 2017 at 8:00 in the evening at the Ormoc City Plaza in connection with the Ormoc Charter Day celebration;

WHEREAS, the parties thereto are committed in collaborating to enter into this contract with full knowledge, commitment and willingness in the fulfillment of their responsibilities contained thereon;
