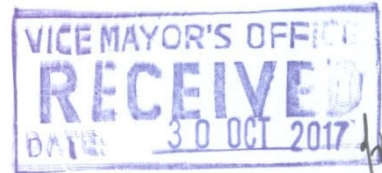

RESOLUTION NO. 2017-243

AN OMNIBUS RESOLUTION AUTHORIZING THE CITY MAYOR  
RICHARD I. GOMEZ TO ENTER INTO AND SIGN THE  
MEMORANDUM OF AGREEMENT (MOA) FOR AND ON  
BEHALF OF THE LOCAL GOVERNMENT OF ORMOC (LGU-  
ORMOC), WITH PUBLIC AND PRIVATE EDUCATIONAL  
INSTITUTIONS FOR THE IMPLEMENTATION OF THE WORK  
IMMERSION PROGRAM REQUIRED UNDER THE SENIOR  
HIGH SCHOOL CURRICULUM.

WHEREAS, this august Body was in receipt of an Indorsement from the Office of the City Mayor dated October 23, 2017, requesting therein for the passage of a resolution granting the City Mayor Richard I. Gomez, authority to enter into and sign the Memorandum of Agreement (MOA) between the City Government of Ormoc and educational public and private institutions in light of the Work Immersion Program of the Department of Education (DepEd), photocopies of the final MOA and its corresponding annexes are hereto attached and made an integral part hereof;

WHEREAS, the DepEd has introduced the K to 12 basic education reform program that includes Senior High School with the major objective of ensuring that graduates of basic education are ready for employment, entrepreneurship and higher learning;

WHEREAS, the DepEd believes that for the effective delivery of Senior High School instructions, there is need for school-industry partnerships that will provide the school the necessary expertise and venue for practical, on the job, expertise - based training for Senior High School learners;

WHEREAS, there are a number of Senior High Schools in Ormoc City who are committed in carrying out DepEd's objectives mentioned above;

WHEREAS, to achieve this objective, Senior High Schools need to enter into a Work Immersion Partnership with the Local Government Unit;

WHEREAS, the City Government of Ormoc is considering a work immersion partnership with the certain Senior High Schools as part of its mission to create an positive impact on the community especially to the young people;

WHEREAS, the City Government and the Department of Education, particularly the Senior High Schools, undertake to collaborate and be responsible for the successful implementation of the Senior High School Program with the awareness of the need for special protection of children who has the best interest to learn;

WHEREAS, the Memorandum of Agreement (MOA) will serve as a instrument for collaborative efforts between the City of Ormoc and the Senior High Schools to further develop life and career skills of students, enhance technical knowledge and skills as well as enrich their skills in communications and human relations;

WHEREAS, upon close and thorough review, this Sanggunian finds that the MOA is not contrary to law, public policy, public morals and existing contracts, and the aim is to foster relationships and strengthen partnerships to students who will be able to apply their competencies and acquired knowledge relevant to their track so therefore, most deserving of this august Body's full support and affirmative action;

WHEREFORE, on motion of SP Member Nolito M. Quilang, Vice Chairman, Committee on Laws and Ordinances and Chairman of the Committee on Education, Culture and the Arts, severally seconded by SP Members Vincent L. Rama, Tomas R. Serafica, Benjamin S. Pongos, Jr., Eusebio Gerardo S. Penserga, Gregorio G. Yrastorza III, John Eualio Nepomuceno O. Aparis II, Lea Doris C. Villar and Mariano Y. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass AN OMNIBUS RESOLUTION AUTHORIZING THE CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT OF ORMOC (LGU-ORMOC), WITH PUBLIC AND PRIVATE EDUCATIONAL INSTITUTIONS FOR THE IMPLEMENTATION OF THE WORK IMMERSION PROGRAM REQUIRED UNDER THE SENIOR HIGH SCHOOL CURRICULUM;
