RESOLUTION NO. 2017-244

A RESOLUTION AUTHORIZING CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN TWO (2) TRIPARTITE MEMORANDA OF AGREEMENT (TMOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT OF CITYON, INC.
ORMCC, WITH RAMON ABOITIZ FOUNDATION, INC. ELEMENTARY SCHOOL **FOR** THEREMABILITATION PROGRAM OF IDENTIFIED EARTHQUAKE AFFECTED SCHOOLS IN ORMOC CITY.

WHEREAS, acting City Mayor Leo Carmelo L. Locsin, Jr. through an Indorsement dated October 02, 2017 forwarded to this august Body for consideration two (2) Tripartite Memoranda of Agreement (TMOA) to be entered into by LGU-Ormoc with RAFI and the following schools, namely Bagong Elementary School and Gaas Elementary School, which aims to cover the school rehabilitation program of identified earthquake affected schools in Ormoc City, copies of the final TMOA are hereto attached and made an integral part hereof;

WHEREAS, during the 6.5 magnitude earthquake that struck the City of Ormoc last July 6, 2017, several public school buildings were damaged making the same unsafe and unfit for use for students and teachers;

WHEREAS, RAFI wishes to extend its assistance in the rehabilitation of certain identified schools affected during the 6.5 magnitude earthquake through the implementation of its School Rehabilitation Program (SRP) which aims to address the pressing gap in physical facilities of the schools;

WHEREAS, the SRP provides safer and more conducive learning facilities for public elementary school children, as it contributes to the improvement of the quality of education;

WHEREAS, LGU Ormoc, cognizant of the positive impact of the rehabilitation of certain schools affected by the recent earthquake, fully supports the conduct of this program in the city;

WHEREAS, Bagong Elementary School and Gaas elementary Schools were two of the schools identified by RAFI, LGU Ormoc and the DepEd Ormoc City Division to be severely affected by the 6.5 magnitude earthquake;

WHEREAS, the Local Government Code of 1991 provides conditions and instances where LGUs may enter into joint ventures and arrangements for economic, socially-oriented, environmental or cultural projects within its jurisdiction;

WHEREAS, the subject TMOA clearly and plainty encapsulate the terms and conditions of the agreement of the parties thereto, including their specific roles, obligations and responsibilities for the successful implementation of the project;

WHEREAS, upon close and thorough review, this Sanggunian finds that the TMOA are not contrary to law, public policy, public morals and existing contracts, and the aim is to successfully construct a one (1) story school building with three (3) classrooms in each school in the hope of providing schoolcaldren the effective learning environment they deserve so therefore, most deserving of this august Body's full support and affirmative action;

WHEREFORE, in motion of SP Member Nolito M. Quilang, Vice Chairman, Committee Laws and Ordinances and Chairman of the Committee on Education, Culture and the Arts, severally seconded by SP Members Tomas R. Serafica, Benjamin S. Pongos, Jr., Eusebio Gerardo S. Penserga, Vincent L. Rama, Gregorio G. Yrastorza III, John Eulalio Nepomuceno O. Aparis II, Lea Doris C. Villar and Mariano Y Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION AUTHORIZING CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN TWO (2) TRIPARTITE MEMORANDA OF AGREEMENT (TMOA) FOR AND ON BEHALF OF THE LOCAL COVERNMENT OF ORMOC (LGU-ORMOC), WITH RAMON ABOITIZ FOUNDATION, INC. (RAFI) AND (1) BAGONG ELEMENTARY SCHOOL AND (2) GAAS ELEMENTARY SCHOOL FOR THE SCHOOL REHABILITATION PROGRAM OF IDENTIFIED EARTHQUAKE AFFECTED SCHOOLS IN ORMOC CITY;
