## RESOLUTION NO. 2017-246

A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ, FOR AND ON BEHALF OF LOCAL GOVERNMENT UNIT OF ORMOC CITY (LGU-ORMOC), TO ACCEPT AND SIGN THE DEED OF DONATION OF FORTY FOUR (44) KITS OF TAMANG SERBISYO SA KALUSUGAN NG PAMILYM (TSEXAR) BY THE DEPARTMENT OF HEALTH REGIONAL OFFICE VIII (DOH-RO8) AS DONOR IN FAVOR GU-ORMOS AS DONEE.

WHEREAS, this august Body was in receipt of an Indorsement from the Office the City Mayor Richard I. Gomez addressed to the Vice Mayor Leo Carmelo L. Locsin, Jr., City Vice Mayor & Presiding Officer of the 14th Sangguniang Panlungsod ng Ormoc dated October 04, 2017 requesting for the issuance of a resolution granting Mayor Richard I. Gomez the authority to accept and sign the attached Deed of Donation (DOD) of Forty Four (44) Kits of Tamang Serbisyo sa Kalusugan ng Pamilya (TSeKaP) by DOH Regional Office VIII to LGU Ormoc, a copy of said Deed of Donation is hereto attached and made an integral part thereof;

WHEREAS, the State recognizes its mandate to provide equitable and accessible quality health care for all Filipinos through the provision of primary health care in Rural Health Units and Barangay Health Stations;

WHEREAS, TSeKaP was introduced under Primary Care Benefit program of Philhealth which provides an essential package of health services including complete physical examination such as weighing of children under 5 years old, developmental assessment of infants, blood pressure measurement, eye, ear and dental examination, and breast exam and a number of laboratory tests;

WHEREAS, the distribution of TSeKap packages aims to equip LGUs with the essential medical equipment that designed to address common health problem seen in the primary health care leading to overall objective which is to improve better health outcomes and increase financial risk protection;

WHEREAS, forty four (44) health kits have already been received by the Local Government Unit of Ormoc last 2016;

WHEREAS, pursuant to Department Memorandum No. 2017-0264 from the Office of the Secretary of the Department of Health in compliance with COA AOM No. 2017-101-03, the HFEP Equipment distributed to various LGUs have no corresponding MOA or DOD or any documents for transfer of assets and that a DOD should have been accomplished on or before July 28, 2017 to the Health Facility Development Bureau;

WHEREAS, this Sanggunian, after thorough examination of the aforementioned request by the City Mayor finds that it is to the best interest of the City and advantageous to the same to authorize the City Mayor to sign the Deed of Donation and accept the kits in order to be used in rural health centers and barangay health stations in the City;

WHEREFORE, on joint motion of SP Member Benjamin S. Pongos, Jr. Chairman, Committee Laws and Ordinances and SP Member Mario M. Aparis II and Mariano Y. Corra; be it
