*A RESOLUTION APPROVING THE PURCHASE OF ONE (1) UNIT  
BRAND NEW SERVICE VEHICLE FOR THE OFFICE OF THE  
BUILDING OFFICIAL (OBO) USE.*

WHEREAS, forwarded to this august Body for consideration, is an Endorsement dated October 23, 2017, from the Office of the City Mayor, pertaining to the request of Engr. Sonia B. Antonio, OIC-Building Official, for a resolution approving the purchase of a one (1) unit Service Vehicle with an estimated cost of ONE MILLION FIVE HUNDRED THOUSAND PESOS (P1,500,000.00);

WHEREAS, The Office of the Building Official functions as the primary administering office to implement regulations, examine permits and requirements for construction, repair, use, occupancy and conversion as well as demolition of buildings in conformity with the National Building Code of the Philippines;

WHEREAS, as a newly created office, the OBO is mandated to perform complex functions geared towards ensuring a timely evaluation and processing of building-related documents as well strict enforcement of building policies. Relative thereto, the Office diligently conducts regular inspections within the city thus, the need to procure a service vehicle for easy mobilization and to effectively carry out its mandate;

WHEREAS, the essential funds to cover the proposed vehicle purchase is available as certified by the OIC-City Accountant through a Certificate of Availability of Funds dated September 14, 2017, to be taken from the CY 2017-OBO 15% Accumulated Fund (SL Code 004-001-0001) in the amount of ONE MILLION FIVE HUNDRED THOUSAND PESOS (P1,500,000.00);
