- RESOLUTION APPROVING THE SEVEN (7) SEPARATE APPLICATIONS FOR ACCREDITATION WITH THE LOCAL GOVERNMENT UNIT OF ORMOC, IN ACCORDANCE WITH THE PROVISIONS OF ORDINANCE THE NO. 009 DATED OCTOBER 16, 2014 OF THE FOLLOWING CIVIL SOCIETY ORGANIZATIONS, TO WIT:

WHEREAS, this Sanggunian received the applications for accreditation with the Local Government Unit of Ormoc of the following Civil Society Organizations (CSOs), to wit;

WHEREAS, Metro Ormoc Community Multi-Purpose Cooperative (MOCMPC), is a duly organized cooperative registered with Cooperative Development Authority (CDA) that strives to provide quality and diversified financial products and related services that will respond to the socio-economic and spiritual needs of the members and the community as well. It is also actively participating in any cooperative movement in coordination with LGU-Ormoc and other authorized agencies;

WHEREAS, Taytay sa Kauswagan, INC. (TSKI), is a non-stock, non-profit Christian Development Organization registered under the Securities and Exchange Commission (SEC) that provides micro financing to small and medium entrepreneurs and socio-cultural activities. TSKI aspires to assist the people, especially the poor to hurdle poverty confining attitudes and lifestyles through the conduct of value formation and business skills training;

WHEREAS, Bellas Survivor Homeowners Association, Inc. (BSHOA) is a non-profit, non-stock association composed of residents from Brgy. Can-untog and registered under the Housing and Land Use Regulatory Board (HLURB). Its primary concern is to organize and encourage poor families to acquire their own lot for their lifetime dwellings. The association also focuses on the promotion, enhancement and fostering development and improvement of quality of life among its members through livelihood projects and other economic activities;

WHEREAS, Earangay Health Workers Association of Ormoc City (BHW), is a legitimate health workers association registered under Department of Labor and Employment (DOLE) aimed at creating a meaningful and relevant mechanism and strategies in building partnership with Department of Health and other government agencies. LGUs, and non-government and people's organizations having health development endeavors as genuine partners to community development;

WHEREAS, Coop for Christ-Leyte Multi-Purpose Cooperative (CoFC-LMPC), is a leading Christ-centered cooperative registered with the Cooperative Development Authority (CDA). Among its objectives is to provide optimum social and economic benefit to its members through sustainable appropriate services and application of modern methods of production to attain increased income and productivity of its members;

WHEREAS, Cabintan Livelihood Community Association (CALCOA), is a group of farmers residing in Brgy. Cabintan, this City, registered under Department of Labor and Employment (DOLE). Among its purposes is to encourage thrift savings for each member to form a Capital-Build-Up for the development of the association. It endeavors to assist its members in acquiring modern farming techniques and entrepreneurial skills in order to improve their socio-economic conditions;

WHEREAS, Fran Workers and Farmers Association (FRAWFA), is a local organization recognized as partners in rural development of rice agriculture and that of the City of Agriculture Office. It is registered under the Department of Labor and Employment (DOLE) with the primary purpose of establishing an association that will promote mutual aid and protection for its members and look towards development sustainable livelihood activities to uplift the members in economic condition;

WHEREAS, the call for accreditation of CSOs was pushed by this Sanggunian in accordance with the provisions of Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, Section 2.1 of Ordinance No.009 provides among others that an organization may still be accredited after the prescribed sixty (60) - day period within which application for accreditation shall be accepted, for purposes other than representation to local special bodies;

WHEREAS, this Sanggunian, after thorough review of the aforementioned applications, find that the same are in order, and the purposes of the sought accreditation are all directed to promote mutual aid, protection, and socio-economic development among its members as well as to address issues on livelihood capitalization through the establishment of a strong linkage with the LGU in order for each organization to have a better access to the diverse programs and projects of the government that are beneficial to all sectors of the community;

WHEREAS, further, this august Eody deems the application to be lawful being in accordance with the provisions of Ordinance No. 009 hence, most deserving of favorable action by this Sanggunian,
