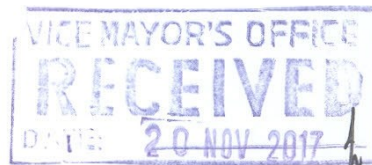

RESOLUTION NO. 2017-259

A RESOLUTION AUTHORIZING THE CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) WITH LGU BARANGAY CAGBUHANGIN, THIS CITY AND SHERYL LYNN FOUNDATION FOR THE CONSTRUCTION OF A CHILDREN'S LEARNING CENTER.

WHEREAS, this Sanggunian received an Indorsement from the Office of the City Mayor dated November 8, 2017 requesting therein for the passage of a resolution granting the City Mayor Richard I. Gomez, authority to enter into and sign the Memorandum of Agreement (MOA) by and between the LGU - Ormoc, LGU Barangay Cagbuhangin and Sheryl Lynn Foundation, a photocopy of the final MOA is hereto attached and made an integral part hereof;

WHEREAS, Sheryl Lynn Foundation, founded by Ms. Netherlands 2006 and Mrs. Globe 2013 Sheryl Lynn Callister, has been actively helping and supporting Filipinos, with a focus on children and education and has expressed its willingness and intention to lend assistance in the construction of a Child Friendly Learning Center located in Barangay Cagbuhangin, Ormoc City, hereinafter known as the Project;

WHEREAS, to recall, this Sanggunian passed SP Resolution No. 098 Series of 2017 interposing no objection to the demolition of the now destroyed Tanod Outpost in Barangay Cagbuhangin so that the Project for the Barangay shall be constructed in its place;

WHEREAS, to further recall, through Sangguniang Barangay Resolution No. 06, Series of 2017 of Barangay Cagbuhangin, the Barangay declared that it is incapable of providing the funds required to implement the Project and is seeking the assistance of LGU-Ormoc in said regard;

WHEREAS, in response to said request for assistance by the Barangay, this Sanggunian finding the same to be meritorious enacted Appropriation Ordinance No. 2017-013 dated June 8, 2017 appropriating the amount of Five Hundred Sixty Three Thousand Eight Hundred Seventy Eight Pesos (PHP563,878.00) as assistance for the Project;

WHEREAS, for the purpose of formalizing the tripartite venture among LGU-Ormoc, LGU Barangay Cagbuhangin and Sheryl Lynn Foundation regarding the implementation and completion of the Child Friendly Learning Center, a MOA among the three parties shall be executed encapsulating the terms and conditions of their intents and purposes relative to the project;

WHEREAS, after careful and thorough review of the subject MOA, this Sanggunian finds that it clearly and plainly encapsulates the terms and conditions of the agreement of the parties thereto, including their specific roles and obligations towards the attainment of the lofty ends of the same, and this august Body further finds that overall it is favorable and advantageous to the residents, particularly the children of Brgy. Cagbuhangin and therefore, is most deserving of its prompt and favorable consideration;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of SP Member Benjamin S. Pongos, Jr., Chairman, Committee on Laws and Ordinances, severally seconded by SP Members Vincent L. Rama, Mario M. Rodriguez, Tomas R. Serafica, Eusebio Gerardo S. Penserga, Gregorio G. Yrastorza III, John Eulalio Nepomuceno O. Aparis II and Mariano Y. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION AUTHORIZING THE CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) WITH LGU BARANGAY CAGBUHANGIN, THIS CITY AND SHERYL LYNN FOUNDATION FOR THE CONSTRUCTION OF A CHILDREN'S LEARNING CENTER;
