RESOLUTION AUTHORIZING THE CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN THE TRIPARTITE MEMORANDUM OF AGREEMENT (TMOA) FOR AND ON OF THE LOCAL GOVERNMENT OF ORMOC (LGU-DRMOC WITH THE REGIONAL TRAINING CENTER (RTC) AND KEINECH EDUCATIONAL FOUNDATION, INC. AND THE TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY (TESDA) FOR THE CONDUCT OF SKILLS TRAINING THROUGH THE COMMUNITY BASED TRAINING (CBT) TO LGU-ORMOC'S DRUG REHABILITATION SERVICES BENEFICIARIES, **SUBJECT** TO **CERTAIN** CONDITIONS.

WHEREAS, this august Body was in receipt of an Indorsement from the Office of the City Mayor dated October 19, 2017, requesting therein for the passage of a resolution granting the City Mayor Richard I. Gomez, authority to enter into and sign the Tripartite Memorandum of Agreement (TMOA) between the LGU-Ormoc, the Regional Training Center (RTC), KEITECH Educational Foundation, Inc. and TESDA for the conduct of Community Based Training (CBT) to LGU Ormoc's Drug Rehabilitation Services beneficiaries, a copy of the final MOA is hereto attached and made an integral part hereof;

WHEREAS, RTC is Technical Education and Skills Development Authority (TESDA)- accredited educational institution that offers Technical and Vocational Education and Training Programs (TVET) and which pursues the conduct of skills training through the Community Based Training (CBT) program and assessment and certification through the Philippine TVET Competency Assessment and Certification System (PTCACS);

WHEREAS, LGU-Ormoc, with its ongoing Drug Rehabilitation Services Program, provides skills training to enhance the capability of its beneficiaries for which purpose it requested the Energy Development Corporation (EDC) through its KEITECH Leyte Campus to conduct skills training on Motorcycle or Small Engine Servicing to its drug rehabilitation service beneficiaries subject to the condition that the beneficiaries who enrol in the skills training program reaches a number between twenty-five (25) to thirty-five (35) and that if the number of beneficiaries does not reach the mentioned enrollees' number range, LGU-Ormoc shall fill up the deficit by providing indigent enrollees other than those from its drug rehabilitation program;

WHEREAS, Community-based Training under TESDA is primarily addressed to the poor and marginal groups, those who cannot access, or are not accessible by formal training provisions who have no access to capital and is purposively designed to catalyze the creation of livelihood enterprises that shall be implemented by the trainees, immediately after the training;

WHEREAS, likewise, it is designed to assist partner agencies such as LGUs, NGOs, people organizations and other agencies organizations with mission to help the poor get into productive undertakings to help themselves and their communities;

WHEREAS, the skills training under the Community Based Training program to be conducted is the Small Engine Care and Maintenance competency which will be a fifteen (15) day training module which allows the graduates to receive a Certificate of Completion (COC) leading to NC II;

WHEREAS, to achieve this objective, the same would need an execution of a MOA which will serve as a vehicle for collaboration efforts between the LGU-Ormoc, RTC, TESDA and KELTECH Educational Foundation, Inc. which aim to enhance the citizens productivity thru productive livelihood endeavors and self-employment;

WHEREAS, upon close and thorough review, this Sanggunian finds that the MOA is not contrary to law, public policy, public morals and existing contracts, and the aim is properly and effectively implement the skills training program and ensure the institutionalization and sustainability of the MOA program outputs and outcomes and this Sanggunian, upon thorough review, finds that overall it is favorable and advantageous to all parties and therefore, is most deserving of this august Body's prompt and favorable consideration;

WHEREFORE, on motion of SP Member Nolito M. Quilang, Chairman, Committee on Education, Culture & the Arts, severally seconded by SP Members Mariano Y. Corro, John Eulalio Nepomuceno O. Aparis II, Eusebio Gerardo S. Penserga and Tomas R. Serafica; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION AUTHORIZING THE CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN THE TRIPARTITE MEMORANDUM OF AGREEMENT (TMOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT OF ORMOC (LGU-ORMOC), WITH THE REGIONAL TRAINING CENTER (RTC) AND KEITECH EDUCATIONAL FOUNDATION, INC. AND THE TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY (TESDA) FOR THE CONDUCT OF SKILLS TRAINING THROUGH THE COMMUNITY BASED TRAINING (CBT) TO LGU ORMOC'S DRUG REHABILITATION SERVICES BENEFICIARIES, SUBJECT TO CERTAIN CONDITIONS;
