RESOLUTION NO. 2017-271

A RESOLUTION APPROVING THE APPLICATION FOR
ACCREDITATION WITH THE LOCAL GOVERNMENT UNIT OF
ORMOC OF LIBERTY VEGETABLE FARMERS ASSOCIATION
(LIVEFA), IN ACCORDANCE WITH THE PROVISIONS OF
ORDINANCE NO. 009 DATED OCTOBER 16, 2014.

WHEREAS, this august Body received the application of Liberty Vegetable Farmers Association (LIVEFA), a Civil Society Organization (CSO) requesting for accreditation with the Local Government Unit of Ormoc;

WHEREAS, LIVEFA is composed of farmers residing in Barangay Liberty, this City and was registered with the Department of Labor and Employment (DOLE). Among its primary objectives is to promote the mutual aid and protection of its members as well as to avail assistance from the national and local agencies/NGOs specifically in the agriculture based programs for sustainable livelihood which will translate to additional income for its members;

WHEREAS, it can be recalled that this Sanggunian has enacted Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, Section 2.1 of Ordinance No.009 provides among others that an organization may still be accredited after the prescribed sixty (60) – day period within which application for accreditation shall be accepted, for purposes other than representation to local special bodies;

WHEREAS, this Sanggunian, after thorough review of the aforementioned application, finds that the same is in order, and the purpose of the sought accreditation is for the abovementioned organization to move forward its noble intention to promote moral, social and economic development among its members through the establishment of a strong linkage with the LGU in order for the association to have a better access to future agricultural programs of the government that are beneficial to its members;

WHEREAS, further, this august Body deems the application to be lawful being in accordance with the provisions of Ordinance No. 009 hence, most deserving of favorable action by this Sanggunian;

WHEREFORE, on motion of the SP Member Eusebio Gerardo S. Penserga, Chairman, Committee on Accreditation, severally seconded by the SP Members Vincent L. Rama, Tomas R. Serafica, Benjamin S. Pongos, Jr., Nolito M. Quilang, Lea Doris C. Villar and Mariano Y. Corro; be it

RESOLVED AS IT IS HEREBY RESOLVED, to pass a RESOLUTION APPROVING THE APPLICATION FOR ACCREDITATION WITH THE LOCAL GOVERNMENT UNIT OF ORMOC OF LIBERTY VEGETABLE FARMERS ASSOCIATION (LIVEFA), IN ACCORDANCE WITH THE PROVISIONS OF ORDINANCE NO. 009 DATED OCTOBER 16, 2014;
