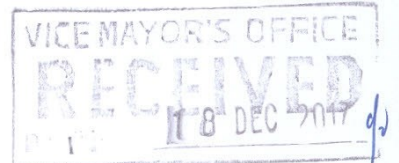

RESOLUTION NO. 2017-275

A RESOLUTION GRANTING AUTHORITY TO CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) WITH THE PHILIPPINE BUSINESS FOR SOCIAL PROGRESS, INC. ((PBSP) REPRESENTED BY ITS EXECUTIVE DIRECTOR, MR. REYNALDO ANTONIO D. LAGUDA FOR THE IMPLEMENTATION OF PROGRAMMATIC MANAGEMENT OF DRUG-RESISTANT TUBERCULOSIS (PMDT) IN ORMOC CITY FOR CY 2017.

WHEREAS, the Fourteenth Sangguniang Panlungsod ng Ormoc received an Endorsement from the Office of the City Mayor dated November 29, 2017 requesting for the passage of a resolution granting authority to the City Mayor Richard I. Gomez to enter into and sign a Memorandum of Agreement (MOA) for and on behalf of the Local Government Unit of Ormoc (LGU-Ormoc) with the Philippine Business for Social Progress, Inc. (PBSP) represented by its Executive Director, Mr. Reynaldo Antonio D. Laguda relative to the implementation of the Programmatic Management of Drug-resistant Tuberculosis (PMDT) in Ormoc City, a copy of the MOA is hereto attached and made an integral part hereof;

WHEREAS, PMDT is a vital program on health primarily to address the threats of Drug-Resistant Tuberculosis (DR-TB) which is a major public health concern at present;

WHEREAS, the Philippine Business for Social Progress, Inc. (PBSP) I, a non-profit social development foundation at the forefront in the fight against poverty, is the principal recipient of the Global Fund New Funding Model Grant Costed Extension for TB in the Philippines (referred to as the "GF Project") from January 1-December 31, 2017 mainly aimed at further reducing the prevalence, incidence and mortality of TB in the Philippines;

WHEREAS, one of the key service delivery areas of the GF Project is the implementation of PMDT nationwide undertaken by the PBSP being the principal recipient of the GF Project in cooperation with the Department of Health –National Tuberculosis Program (DOH-NTP);

WHEREAS, LGU-Ormoc through its City Health Office fully supports the implementation of the PMDT in Ormoc City towards the achievement of the goal to combat the very problematic and difficult to treat DR-TB cases;

WHEREAS, PBSP and LGU-Ormoc City Health Office actively worked together since the early months of CY 2017 in delivering PMDT-related services to qualified PMDT patients ensuring therein that those in most need thereof are well-covered and served;

WHEREAS, in order to formalize the collaboration of PBSP and LGU-Ormoc City Health Office with regards to the implementation of PMDT, there is a need to execute a MOA covering the matter to guarantee the continued implementation and sustainability of the program for the good and benefit of the recipient Ormocanons;

WHEREAS, the MOA had undergone the review of the City Legal Officer and was found to be in order and most beneficial to the people hence, recommends for its approval by this Sanggunian;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of SP Member Mario M. Rodriguez, Chairman, Committee on Health and Sanitation, severally by SP Members Vincent L. Rama, Tomas R.
