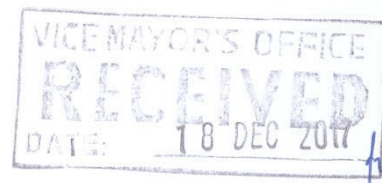

RESOLUTION NO. 2017-276

A RESOLUTION EARNESTLY REQUESTING THE LOCAL GOVERNMENT UNIT OF QUEZON CITY THROUGH CITY MAYOR HERBERT M. BAUTISTA FOR FINANCIAL ASSISTANCE TO COVER THE IMPLEMENTATION AND REALIZATION OF THE FOLLOWING PRIORITY PROJECTS OF THE LOCAL GOVERNMENT UNIT OF ORMOC CITY, TO WIT:

- 1) CONSTRUCTION OF NEW MOTORPOOL BUILDING
- 2) CONSTRUCTION OF NEW ORMOC CITY GRANDSTAND.

WHEREAS, the Local Government Unit of Ormoc City (LGU-Ormoc) at present embarks on various priority projects as part of its rehabilitation efforts in the aftermath of the calamities that struck the city, the most recent of which was the 6.5 magnitude earthquake last July 6, 2017;

WHEREAS, the July 6, 2017 earthquake that hit Ormoc City resulted to severe damages to many government infrastructures and displaced thousands of families that need to be relocated and immediately provided with housing assistance;

WHEREAS, the massive rehabilitation efforts require substantial amount of resources confronting the limited local financial resources of LGU Ormoc which also need to ensure that development programs are not paralyzed and various services will continue to serve the general public;

WHEREAS, the administration of Mayor Richard Gomez is determined to pursue the various priority programs for rehabilitation despite the limited financial resources as the City Government is confident of the generosity and benevolence of other local government units and various individuals and groups who provided support and various assistance to help Ormoc City rise again after the most recent calamity;



WHEREAS, among the top priority projects identified by the present administration are the following: 1.) Construction of New Motorpool Building, and 2) Construction of New Ormoc City Grandstand, copies of the Program of Works covering each project are hereto attached and made an integral part hereof;

WHEREAS, the Construction of the New Motorpool Building is necessary to better secure the government vehicles as these are crucial during calamities and the said building is old and is severely damaged;

WHEREAS, the Construction of the New Grandstand is necessary considering that the existing grandstand was declared unfit for use after the July 2017 earthquake and the city is unable to host major sports and other tourism activities with the only grandstand not available for public use;

WHEREAS, fully aware of the limited capability of the city vis-a-vis the substantial amount of funds required to carry out the abovementioned projects, City Mayor Richard I. Gomez forwarded two urgent endorsements both dated November 15, 2017 to the 14<sup>th</sup> Sangguniang Panlungsod ng Ormoc requesting therein for the passage of a resolution requesting financial assistance from LGU-Quezon City to fulfill his dream of securing the government vehicles and giving the people of Ormoc a safe and more secure grandstand to be used for major activities in the city oval;

WHEREAS, this Sanggunian has already formally conveyed a resolution inviting Quezon City to a sisterhood agreement with Ormoc City and the latter is now communicating and coordinating with pertinent officials in Quezon City for the details of the requirements for the said sisterhood and considering that the sisterhood processes are still being undertaken the endorsements from the Office of Mayor Richard Gomez become necessary for these specific projects may not be able to wait for the conclusion of the ongoing sisterhood processes;

WHEREAS, this Sanggunian finds the request of the City Mayor deserving of indubitable support as it will translate to the betterment and improvement of public service as well as in the promotion and development of tourism, sports and other socio- economic potentials of the city which will ultimately redound to the general welfare of the people;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of SP Member Nolito M. Quilang, Chairman, Committee on Cities Sisterhood Program, severally seconded by SP Members Tomas R. Serafica, Vincent L. Rama, Rolando M. Villasencio, Eusebio Gerardo S. Penserga, Gregorio G. Yrastorza III, John Eulalio Nepomuceno O. Aparis II, Lea Doris C. Villar and Mariano Y. Corro; be it --

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION EARNESTLY REQUESTING THE LOCAL GOVERNMENT UNIT OF QUEZON CITY THROUGH CITY MAYOR HERBERT M. BAUTISTA FOR FINANCIAL ASSISTANCE TO COVER THE IMPLEMENTATION AND REALIZATION OF THE FOLLOWING PRIORITY PROJECTS OF THE LOCAL GOVERNMENT UNIT OF ORMOC CITY, TO WIT:

- 1) CONSTRUCTION OF NEW MOTORPOOL BUILDING
- 2) CONSTRUCTION OF NEW ORMOC CITY GRANDSTAND.
