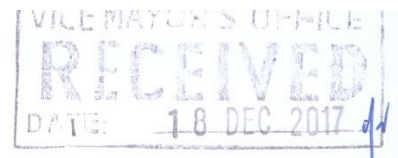

RESOLUTION NO. 2017-278

A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN THE JOINT AFFIDAVIT OF UNDERTAKING OF MAYOR RICHARD I. GOMEZ AND FE L. COMORPOSA RE: POLLUTION CONTROL OFFICER ACCREDITATION OF ORMOC CITY, FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC).

WHEREAS, the Office of SP Member Gregorio G. Yrastorza, III, Chairman of the Committee on Environment and Natural Resources and SP Member Benjamin S. Pongos, Jr., Chairman of the Committee on Laws and Ordinances were in receipt of an Indorsement from the Office of the City Vice Mayor dated December 04, 2017 in lieu of December 07, 2017 Regular Session, requesting therein for the passage of a resolution granting the City Mayor Richard I. Gomez, authority to sign the Joint Undertaking of Mayor Richard I. Gomez and Fe L. Comorposa Re: Pollution Control Officer Accreditation of Ormoc City, for and on behalf of the Local Government Unit (LGU) of Ormoc, a photocopy of the final Joint Affidavit of Undertaking is hereto attached and made an integral part hereof;

WHEREAS, this Joint Undertaking is to ensure compliance with the requirements of Presidential Decree No. 1586 or the Law Establishing the Environmental Impact Statement System (EISS), Republic Act No. 9003 otherwise known as Ecological Solid Waste Management Act of 2000, Republic Act No. 6969 or the Toxic Substances and Hazardous and Nuclear Wastes Control Act of 1990, Republic Act No. 8749 otherwise known as the Philippine Clean Air Act of 1999, Republic Act 9275 or the Philippine Clean Water Act of 2004, their respective Implementing Rules and Regulations (IRR) and other pertinent rules and regulations;

WHEREAS, this is also to ensure the proper performance, operation and maintenance of environmental management facilities or systems of the establishments, including pollution control facilities to ensure compliance with the Effluent Standards and report monitoring results to the Department of Environment and Natural Resources (DENR);

WHEREAS, monitoring of the compliance of the requirements specified in the Environmental Compliance Certificate (ECC), compliance with the National Emission Standards for Source Specific Air Pollutants and National Ambient Air Quality Standards, use of chemicals and generation of solid and hazardous wastes are some of the vital duties and responsibilities of the parties laid down under this undertaking because of its great environmental impacts;

WHEREAS, this Joint Undertaking will also serve as guide for the parties to effectively comply and perform their duties and responsibilities laid down and specified therein;

WHEREAS, upon close and thorough review, this Sanggunian finds that the Joint Undertaking is not contrary to law, public policy, public morals and existing contracts, and that the aim of this undertaking is highly noble that will greatly benefit the inhabitants of the City and its environment, so therefore, most deserving of this august Body's full support and affirmative action;

WHEREFORE, on joint motion of SP Member Gregorio G. Yrastorza III, Chairman, Committee on Environment and Natural Resources and SP Member Benjamin S. Pongos, Jr., Chairman of the Committee on Laws and Ordinances, severally seconded by SP Members Vincent L. Rama, Tomas R. Serafica, Eusebio Gerardo S. Penserga and Mariano Y. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN THE JOINT AFFIDAVIT OF UNDERTAKING OF MAYOR RICHARD I. GOMEZ AND FE L. COMORPOSA RE: POLLUTION CONTROL OFFICER ACCREDITATION OF ORMOC CITY, FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC);
