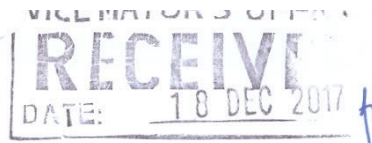

RESOLUTION NO. 2017-284

A RESOLUTION SUPPLEMENTING SANGGUNIANG PANLUNGSOD (SP) RESOLUTION NO. 203 SERIES OF 2017 IDENTIFYING THE SPECIFIC PROJECTS ENDORSED TO THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) IN THE LIST OF PRIORITY PROGRAMS/PROJECTS OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) TO BE FUNDED UNDER THE LOCAL GOVERNMENT SUPPORT FUND- FINANCIAL ASSISTANCE TO LOCAL GOVERNMENT UNITS (LGSF-FA to LGUs) AS PER LOCAL BUDGET CIRCULAR NO. 114 AND ADDITIONALLY, AFFIRMING THAT SUCH PROJECTS/PROGRAMS ARE PART OF THE DULY APPROVED CY 2017 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM OF THE CITY.

WHEREAS, the Office of the City Mayor (CMO) through an Endorsement dated December 12, 2017 requested for the passage of a Sanggunian resolution endorsing the list of priority programs/projects of the Local Government Unit of Ormoc to be funded under the LGSF-FA to LGUs and affirming that such projects or programs are part of the duly approved Annual Investment Program (AIP) of the City, further classifying the same as EXTREMELY URGENT, machine copies of the said list of priority programs/projects are hereto attached and made an integral part hereof;

WHEREAS, to recall, thru SP Resolution No. 2017-03, this Sanggunian had endorsed to the DBM the list of priority programs/projects of LGU Ormoc to be funded under the LGSF-FA to LGUs and affirmed that such projects/programs are part of the duly approved CY 2017 Annual and Supplemental Investment Program of the City but, however, said Resolution failed to specifically enumerate said projects/programs, hence the aforementioned request from the CMO;



WHEREAS, these are the following specific projects/programs to be included in the list of priority projects/programs of LGU-Ormoc to be funded from the said LGSF-FA to LGUs in the total amount of SEVENTEEN MILLION FIVE HUNDRED THOUSAND PESOS (Php 17,500,000.00), to wit:

Financial Assistance for Medical	Php 1,500,000.00
Burial Assistance	Php 500,000.00
Transportation Assistance	Php 500,000.00
Food Assistance	Php 1,698,000.00
Educational Assistance	Php 1,800,000.00
Cash for Work	Php 8,502,000.00

WHEREAS, this Resolution also affirms that the said projects/programs are included in the approved CY 2017 Supplemental Annual Investment Program of the City as provided for in SP Resolution No. 2017-178 entitled: "A RESOLUTION APPROVING THE CY 2017 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 2 OF THE CITY OF ORMOC IN THE AMOUNT OF ONE BILLION TWO HUNDRED FORTY-NINE MILLION FIVE HUNDRED THIRTY-TWO THOUSAND FIVE HUNDRED THIRTY-FOUR PESOS (P1,249,532,534.00) AS CONTAINED IN CITY DEVELOPMENT COUNCIL (CDC) RESOLUTION NO. 5 SERIES OF 2017";

WHEREAS, LGSF-FA to LGUs serves as the National Government's response to the various challenges faced by the LGUs in the exercise of their devolved service delivery functions foremost of which is the raising of sufficient funds for local development;

WHEREAS, LGSF was included in the FY 2017 General Appropriations Act to cover, among others, financial assistance to LGUs as support for its priority programs and projects;

WHEREAS, upon close and thorough review, this Sanggunian finds that the specific local projects/programs that are requested to be funded are noble and worthy as they are intended to cater to various important needs of the City's benefitted constituents, and deemed vital in moving forward towards the envisioned growth and development of the City and so therefore, most deserving of this august Body's full support and affirmative action to the same;

WHEREFORE, on joint motion of SP Member Benjamin S. Pongos Jr., Chairman, Committee on Laws and Ordinances and SP Member Mario M. Rodriguez, Chairman, Committee on Finance & Appropriation, severally seconded by SP Members Rolando M. Villasencio, Vincent L. Rama, Tomas R. Serafica, Eusebio Gerardo S. Penserga, Gregorio G. Yrastorza III, John Eulalio Nepomuceno O. Aparis II, Lea Doris C. Villar and Mariano Y. Corro; be it
