ARESOLUTION APPROVING THE APPLICATIONS FOR ACCREDITATION WITH THE LOCAL GOVERNMENT UNIT OF ORMOC, IN ACCORDANCE WITH THE PROVISIONS OF ORDINANCE NO. 009 DATED OCTOBER 16, 2014 OF THE FOLLOWING CIVIL SOCIETY ORGANIZATIONS, TO WIT:

I. OPROCOMA AGRO-INDUSTRIAL MULTI-PURPOSE COOPERATIVE

2. STO. NIÑO ORGANIC FARMERS ASSOCIATION (SNOFA)

WHEREAS, this Sanggunian received the applications for accreditation with the Local Government Unit of Ormoc of the following Civil Society Organizations (CSOs), to wit;

- 1. Oprocoma Agro-Industrial Multi-Purpose Cooperative
- 2. Sto. Niño Organic Farmers Association (SNOFA)

WHEREAS, Oprocoma Agro-Industrial Multi-Purpose Cooperative, is a registered cooperative under the Cooperative Development Authority (CDA) with the primary objective to help improve the quality of life of its members. Among its purposes is to undertake marketing of sugar and molasses produced by the planter members and sale of Agricultural Farm Implements, Fertilizer, Chemicals, Agricultural Machinery and Equipment needed by the planter members to cultivate their farms, and Lending operation;

WHEREAS, Sto. Niño Organic Farmers Association (SNOFA) is composed of farmers residing in Brgy. Sto. Niño, Ormoc City registered with the Department of Labor and Employment (DOLE) and established for the mutual aid and protection of its members. Among its objectives is to work with non-government organizations and government entities for the promotion and development of the association;

WHEREAS, it can be recalled that this Sanggunian has enacted Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, Section 2.1 of Ordinance No.009 provides among others that an organization may still be accredited after the prescribed sixty (60) – day period within which application for accreditation shall be accepted, for purposes other than representation to local special bodies;

WHEREAS, after close and thorough review of the aforementioned applications, this Sanggunian finds that the same are in order, and the purposes of the sought accreditation are all directed to promote mutual aid, protection, and socio-economic development among its members as well as to establish a strong linkage with the LGU and actively participate in the implementation of the diverse programs and projects of the government to promote inclusive growth;

WHEREAS, further, this august Body deem the applications to be lawful being in accordance with the provisions of Ordinance No. 009 hence, most deserving of favorable action by this Sanggunian;

WHEREFORE, on motion of the SP Member Eusebio Gerardo S. Penserga, Chairman, Committee on Accreditation, severally seconded by the SP Members Tomas R. Serafica, Nolito M. Quilang, John Eulalio Nepomuceno O. Aparis II, Gregorio G. Yrastorza III and Lea Doris C. Villar; be it
