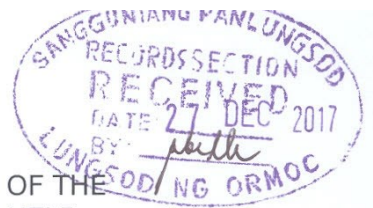

RESOLUTION NO. 2017-294

A RESOLUTION EARNESTLY ENDORSING TO THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) THE FINAL LIST OF PRIORITY PROGRAMS/PROJECTS OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) TO BE FUNDED UNDER THE LOCAL GOVERNMENT SUPPORT FUND- FINANCIAL ASSISTANCE TO LOCAL GOVERNMENT UNITS (LGSF-FA to LGUs) AS PER LOCAL BUDGET CIRCULAR NO. 114 AND ADDITIONALLY, AFFIRMING THAT SUCH PROJECTS/PROGRAMS ARE PART OF THE DULY APPROVED CY 2017 ANNUAL AND SUPPLEMENTAL INVESTMENT PROGRAM OF THE CITY THEREBY SUPERSEDING SP RESOLUTION NOS. 2017-284 AND 2017-203, RESPECTIVELY.

WHEREAS, the Fourteenth Sangguniang Panlungsod ng Ormoc received an urgent Endorsement from the Office of the City Mayor dated December 20, 2017 requesting for the amendment of SP Resolution No. 2017-284, titled: " A RESOLUTION SUPPLEMENTING SANGGUNIANG PANLUNGSOD (SP) RESOLUTION NO. 203 SERIES OF 2017 IDENTIFYING THE SPECIFIC PROJECTS ENDORSED TO THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) IN THE LIST OF PRIORITY PROGRAMS/PROJECTS OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGUORMOC) TO BE FUNDED UNDER THE LOCAL GOVERNMENT SUPPORT FUND-FINANCIAL ASSISTANCE TO LOCAL GOVERNMENT UNITS (LGSF-FA to LGUs) AS PER LOCAL BUDGET CIRCULAR NO. 114 AND ADDITIONALLY, AFFIRMING THAT SUCH PROJECTS/PROGRAMS ARE PART OF THE DULY APPROVED CY 2017 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM OF THE CITY";

WHEREAS, SP Resolution No. 2017-284 particularly dealt with the list of specific projects/programs of LGU-Ormoc which were earlier submitted to DBM to be funded under the LGSF-FA to LGUS specifically described as follows, to wit:

1. Financial Assistance for Medical	-	Php	1,500,000.00
2. Burial Assistance	-	Php	500,000.00
3. Transportation Assistance	-	Php	500,000.00
4. Food Assistance	-	Php	1,698,000.00
5. Educational Assistance	-	Php	1,800,000.00
6. Cash for Work	-	Php	8,502,000.00

WHEREAS, it was found out that the program for the "Hospitalization for Indigent Patients" under the City Health Office with Reference Code 3000-200-12 under the approved CY 2017 AIP of the city was inadvertently omitted from the project list contained in SP Resolution No. 2017-284 which matter is the object of the requested amendment by the City Mayor's Office;

WHEREAS, taking into consideration the amendment proposed by the City Mayor's Office for the inclusion of the aforementioned program in the final list of projects to be funded under the LGSF-FA to LGUs, it is necessary that an appropriate measure covering the proposed amendment be passed, hence this resolution:

WHEREAS, the final list of the programs/projects of LGU Ormoc to be funded under the LGSF-FA to LGUs shall now be as follows:

1. Financial Assistance for Medical	-	Php	1,500,000.00
2. Burial Assistance	-	Php	500,000.00
3. Transportation Assistance	-	Php	500,000.00
4. Food Assistance	-	Php	1,698,000.00
5. Educational Assistance	-	Php	1,800,000.00
6. Cash for Work	-	Php	8,502,000.00
7. Hospitalization Program for Indigent Patients	-	Php	3,000,000.00
TOTAL	-	PhP	17,500,000.00

WHEREAS, LGSF-FA to LGUs serves as the National Government's response to the various challenges faced by the LGUs in the exercise of their devolved service delivery functions foremost of which is the raising of sufficient funds for local development;

WHEREAS, LGSF was included in the FY 2017 General Appropriations Act to cover, among others, financial assistance to LGUs as support for its priority programs and projects;

WHEREAS, upon close and thorough review, this Sanggunian finds that the specific local projects/programs that are requested to be funded are noble and worthy as they are intended to cater to various important needs of the City's benefitted constituents, and deemed vital in moving forward towards the envisioned growth and development of the City and so therefore, most deserving of this august Body's full support and affirmative action to the same;

WHEREFORE, on motion of SP Member Nolito M. Quilang, Vice-Chairman, Committee on Laws and Ordinances, severally seconded by SP Members Tomas R. Serafica, John Eulalio Nepomuceno O. Aparis II, Gregorio G. Yrastorza III and Mariano Y. Corro; be it


