RESOLUTION NO. 2018-003

A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ OR THE ACTING CITY MAYOR, FOR AND ON BEHALF OF LOCAL GOVERNMENT UNIT OF ORMOC CITY (LGU-ORMOC), TO ACCEPT AND SIGN THE DEED OF DONATION RELATIVE TO THE TRANSFER OF OWNERSHIP OF THE ORMOC COMMUNITY EVACUATION CENTER BUILDING, PHOTOVOLTAIC SOLAR PANEL SYSTEM AND GENERATOR SET (SN 155U-11 71106) FROM THE UNITED NATIONS DEVELOPMENT PROGRAMME PHILIPPINE COUNTRY OFFICE.

WHEREAS, this Sanggunian was in receipt of a communication from the Office of the City Mayor Richard I. Gomez dated December 15, 2017 endorsing the recommendation of Atty. Jasper M. Lucero, City Legal Officer, for an issuance of a Resolution granting the City Mayor the authority to sign the Deed of Donation from the United Nations Development Programme Philippine Country Office, a copy of said Deed of Donation and Transfer of Title of Assets are hereto attached and made an integral part hereof;

WHEREAS, pursuant to Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, every Local Government Unit shall exercise the powers expressly granted, those necessary implied therefrom, as well as powers necessary, appropriate or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Ormoc City has been frequently affected by climate-related weather events in recent years which have damaged property and caused the loss of many lives and that every time a typhoon hits the City or when monsoon rains cause heavy flooding, many Ormocanons are displaced and need to be relocated to evacuation centers;

WHEREAS, the United Nations Development Programme Philippine Country Office (UNDP), represented by Mr. Enrico Gaveglia, Deputy Country Director, has caused the donation of the ORMOC Community Evacuation Center Building, a Photovoltaic Solar Panel System and a Generator Set to the City Government of Ormoc for the effective performance of its governmental functions and efficient delivery of basic services to its constituents particularly during times of calamity by providing a permanent relief center with necessary facilities which will address the issues encountered by evacuees such as congestion and exposure to hazard during calamities;

WHEREAS, UNDP is the rightful and legal owner of the assets more particularly described as follows:

WHEREAS, said Deed of Donation mentions that in consideration of an act of cooperation, liberality and generosity, the Donor, UNDP, voluntarily gives, transfers and conveys by way of donation unto the Donee, LGU-Ormoc, the above described assets, free from all liens, encumbrances and charges of whatever kind;

WHEREAS, the assets have been found to represent part of the assistance of UNDP to the Government of the Philippines in connection with LGU-Ormoc, for the Recovery & Resilience in the Visayas;

WHEREAS, the City Legal Officer has expressed an opinion that the said Deed of Donation is in order, not detrimental to the interests of the city, not contrary to law, morals and public policy;

WHEREAS, an authority for the City Mayor to accept and sign for and on behalf of the LGU-Ormoc is necessary for the execution of the Deed;

WHEREAS, the said donated properties shall be considered as forming part of City properties for public use pursuant to the applicable provisions of the Civil Code and other applicable laws;

WHEREAS, LGU-Ormoc expresses its gratitude and utmost appreciation for the support, kindness and liberality of the Donor;

WHEREAS, this Sanggunian, after thorough examination of the aforementioned request finds that it is to the best interest of the City and advantageous to the same to authorize the City Mayor to sign and accept the Deed of Donation and Transfer of Title of Assets that are intended to cater to displaced Ormocanons in times of typhoon and heavy rains and therefore, most advantageous to the City, thereby, certainly deserving of this august Body's prompt and affirmative consideration and action;

Rodriguez, Eusebio Gerardo S. Penserga, Gregorio G. Yrastorza III, Nolito M. Quilang, John Eulalio Nepomuceno O. Aparis II and Mariano Y. Corro; be it

GOMEZ OR THE ACTING CITY MAYOR, FOR AND ON BEHALF OF LOCAL GOVERNMENT UNIT OF ORMOC CITY (LGU-ORMOC), TO ACCEPT AND SIGN THE DEED OF DONATION RELATIVE TO THE TRANSFER OF OWNERSHIP OF THE ORMOC COMMUNITY EVACUATION CENTER BUILDING, PHOTOVOLTAIC SOLAR PANEL SYSTEM AND GENERATOR SET (SN 155U-11 71106) FROM THE UNITED NATIONS DEVELOPMENT PROGRAMME PHILIPPINE COUNTRY OFFICE;


ADOPTED, January 04, 2018.
