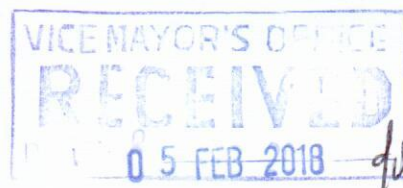

**RESOLUTION NO. 2018-028**

**A RESOLUTION EARNESTLY ENDORSING TO THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) A LIST OF PRIORITY PROJECTS OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) IN THE TOTAL AMOUNT OF SEVENTEEN MILLION FIVE HUNDRED THOUSAND PESOS (PHP17,500,000.00) TO BE FUNDED UNDER THE LOCAL GOVERNMENT SUPPORT FUND- FINANCIAL ASSISTANCE TO LOCAL GOVERNMENT UNITS (LGSF-FA TO LGUs) AND AFFIRMING THAT SUCH PROJECTS/PROGRAMS ARE PART OF THE DULY APPROVED CY 2017 ANNUAL AND SUPPLEMENTAL INVESTMENT PROGRAM OF THE CITY.**

WHEREAS, the Fourteenth Sangguniang Panlungsod received an urgent Endorsement from the Office of the City Mayor dated January 29, 2018 requesting for the issuance of a Resolution stating a specification of the list of priority projects in the total amount of SEVENTEEN MILLION FIVE HUNDRED THOUSAND PESOS (PHP 17,500,000.00) covering Health (Assistance to indigent patients either confined or outpatient including professional fees), Social Services (Educational Assistance) and Construction, et al. of open and closed sports facilities at the Ormoc City Central School and endorsing the same along with affirming that the said project for funding is part of the duly approved Annual Investment Program (AIP) of the city, further classifying the same as EXTREMELY URGENT;

WHEREAS, the requested resolution is pursuant to the requirements set under Item No. 3.0 of the Local Budget Circular (LBC) No. 114 dated March 6, 2017 which subject is the "Guidelines on the Release and Utilization of the FY 2017 Local Government Support- Fund Financial Assistance to Local Government Units (LGSF-FA to LGUs)";



WHEREAS, SP Resolution 2017-294 was passed which contained a list of specific projects/programs of LGU-Ormoc which were earlier submitted to DBM to be funded under the LGSF-FA to LGUs;

WHEREAS, in the above mentioned Endorsement, there is a request for amendment in the said SP Resolution of the specification of list of priority projects and programs under the approved AIP 2017 that are to be funded by the DBM's LGSF-FA to LGUs;

WHEREAS, taking into consideration the amendment proposed by the City Mayor's Office for the inclusion of the aforementioned program in the final list of projects/programs to be funded under the LGSF-FA to LGUs, it is necessary that an appropriate measure covering the proposed amendment be passed, hence this resolution;

WHEREAS, the final list of the programs/projects of LGU Ormoc to be funded under the LGSF-FA to LGUs shall now be as follows:

1. Health (Assistance to indigent patients Either confined or outpatient including professional fees)	-	PhP 7,500,000.00
2. Social Services (Educational Assistance)	-	PhP 5, 000,000.00
3. Construction, et al. (open and closed sports facilities but not including sports equipment) at Ormoc City Central School	-	PhP 5, 000,000.00

TOTAL	-	PhP 17,500,000.00

WHEREAS, the proposed projects for funding are part of the duly approved Annual Investment Program of the LGU after being identified and determined to be consistent with the City's development thrusts, and this Sanggunian fully supports the City Mayor's intention of favorable forwarding the subject list of projects/programs to be covered under the LGSF-FA program;

WHEREAS, LGSF-FA to LGUs serves as the National Government's response to the various challenges faced by the LGUs in the exercise of their devolved service delivery functions foremost of which is the raising of sufficient funds for local development;

WHEREAS, LGSF was included in the FY 2017 General Appropriations Act to cover, among others, financial assistance to LGUs as support for its priority programs and projects;

WHEREAS, upon close and thorough review, this Sanggunian, finds that the specific local projects/programs that are requested to be funded are noble and worthy as they are intended to cater to various important needs of the City's benefitted constituents, and deemed vital in moving forward towards the envisioned growth and development of the City and so therefore, most deserving of this august Body's full support, endorsement and affirmative action to the same;



WHEREFORE, on motion of SP Member Benjamin S. Pongos, Jr., Vice-Chairman, Committee on Finance and Appropriation, severally seconded by SP Members Vincent L. Rama, Mario M. Rodriguez, Tomas R. Serafica, Eusebio Gerardo S. Penserga, Gregorio G. Yrastorza III, Nolito M. Quilang and John Eulalio Nepomuceno O. Aparis II; be it
